HALF OF TECH FUND ALREADY SECURED

Alumni of Institution Are
Gratified Over Success of
Movement to Raise \$100,-
000 in Atlanta.

The Atlanta Alumni of Georgia Tech have plunged into the work of the greater Tech campaign, and are securing results which are gratifying to the leaders of the Tech campaign, and to themselves.

Numerous committees of two, consisting of one of the young alumni of Tech, and an older business man of Atlanta interested in the campaign, were busy Wednesday securing the subscriptions to the fund in Atlanta. Although the subscriptions which were received have not been announced by the executive committee of the campaign, it has been given out that very nearly half of the fund to be secured has already been subscribed, and the leaders and workers are anxious in securing the entire sum immediately.

Will Come in More Rapidly.
It is expected that the subscriptions will come in more rapidly than in the first week, and during next week, for the reason that a number of business houses and corporations have been obliged to be passed on by their boards of directors before announcing the subscriptions, although there was reasonable certainty that the subscriptions will be made.

In this manner the faithful work which has been done by the committees and executive committee of the campaign will be more abundantly in the latter part of the campaign.

The impetus which has been given by the committees from the alumni is expected to bring it to a successful conclusion, as was anticipated at first. At no time during the campaign has failure been considered as a possibility, and the passing of the campaign mark will render the success of the campaign more certain, may the success, for Atlanta never does things halfway.

The success which has been the fortune of this campaign, rather than in the history of campaigns in Atlanta, is attracting attention throughout the rest of the state, and throughout the United States.

Letters have been received from friends of Georgia Tech as far away as San Francisco and the Philippines, sending their congratulations and hopes for the success of greater Tech.

It is the purpose of the leaders after the campaign is a successful close, and subscriptions of \$100,000, the donation of an equal amount of machinery and apparatus, and the construction of a new building, shall have been secured, that the campaign be extended to other cities in the state, and the remainder of the fund necessary for greater Tech will be secured outside of Atlanta.

All Classes to Help.
Representatives of every class which has graduated at Georgia Tech, with a few exceptions, have promised donations from their respective classes, guaranteeing that the amount which they have pledged will be secured.

W. H. Krieshaber varied this program by making a donation for the class of 1913, while his young grandson is expected to enter in the name of the class of 1915.

The last days of the campaign are at hand, and Atlanta is bracing to close another of a long list of successes which she has achieved, and a single failure marked against her.

It was quite a task for one man, in fact, too much of a task, but inasmuch as Councilman Ashley promised the ladies that the work would be done, he set out with several helpers, and at noon he had several departments of the city work on the grounds, and with the exception of the tennis court, the job will be completed before the end of the week.

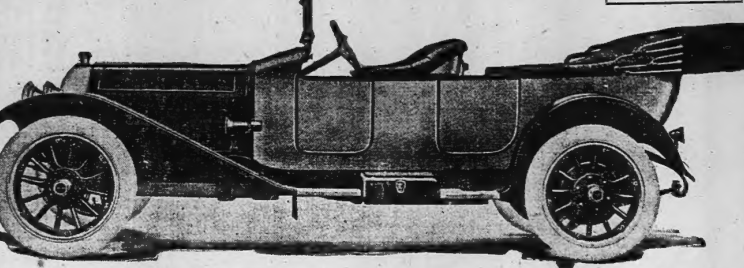
BIRMINGHAM AUTOISTS ARE SOUGHT BY POLICE

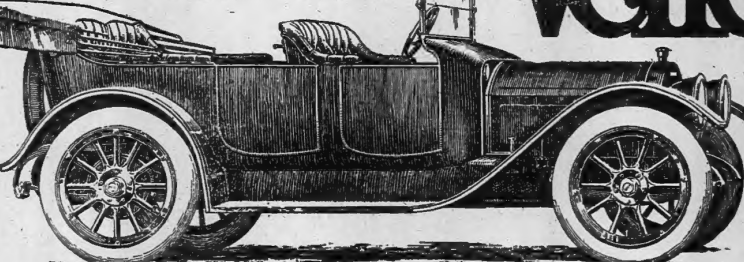
