British artillery arm has been greatly strengthened and claims that it had gained the ascendancy over the Germans. There have been many reports that British heavy guns have been constructed to fire over land and these apparently now are in service.

A Berlin dispatch says an aeroplane, presumably French, has dropped bombs on the German lines in the Dutch territory, but no news of such an occurrence has been received from Berlin.

The Balkan states evidently are furthering their efforts to reach an understanding of the situation before entering the conflict. In this adjustment it is presumed that Bulgaria will get maximal territorial compensation from both Serbia and

Montenegro.

GERMANS MASSING IN EAST PRUSSIA.

Berlin, February 12.—(By Wire)—A Russian retirement from East Prussia, the general staff announces. It is due to necessary reinforcements to the front.

In the western war theater only artillery duels took place. The enemy had to give up the offensive and the counteroffensive against German positions in Champagne, without gaining any success. The British, however, were successful in the attack, but was repulsed with the loss of 120 prisoners.

The number of prisoners in the Argonne was reported yesterday to have been increased by one officer and 118 men. The British had lost 110 men in the enemy's trenches were taken.

**Rev. Carr's Word.**

To the Rev. Carr's explanation that the books issued by the headquarters of the party had been mainly written by the Knights of Columbus, Mr. Goldstein retorted: "You have certainly changed your mind, for in your paper, The Christian Babe's books because of their support of free love. **FEDERAL RESERVE BOARD  
RULES ON ACCEPTANCES****Step to Bring American Fi-  
nances in Accord With  
Other Nations.**

Washington, February 12.—Another step in the development of American finance designed to bring it more in accord with that of other nations was taken yesterday by the Federal Reserve Board when it issued regulations governing the discount or purchase of foreign acceptances.

The federal reserve act authorized national banks to purchase acceptances based on the import or export of merchandise. The board's regulations indicate how banks may attain the maximum benefit of the act.

Before the reserve act was passed domestic dealers in acceptances had been compelled to go to foreign companies and private banks. How far American banks now may proceed in this business, a considerable part of which is done with South American, or for that matter, with European firms, is the guest.

**Payment in Dollars.**

Although under the new regulations the reserves are not barred from outright purchases of acceptances, the board indicates a present preference for payment in dollars, inasmuch as the member banks are not bound to acceptances in any other currency.

The acceptance must be "payable in dollars in the United States," a step up from the old rule of the medium of international exchange.

In preparing the resolution, and many of the other recommendations of the board to the government, some of the governors of federal reserve banks and the Federal Reserve Board.

**The Acceptance is Still in Its Infancy.**

TITLES AND RURAL CREDITS.

This fact should be well grounded into the minds of the legislators at the forthcoming session of the general assembly:

No system of rural credits that may be devised by the federal government will be of maximum service to Georgia until our wracked and tangled system of land titles is corrected.

Rural credits are based, primarily, upon land. In order that the security is sound the title must be sound. Anyone who has tried to run down a title of any variety in farm or city property knows how difficult, complicated and costly is the process, with delay and final uncertainty the outcome.

Operating a rural credit system under this handicap means that Georgia will not get proportionately anything resembling the benefit out of the innovation enjoyed by states more up to date.

As it now is, the cumbrous title system is one link in the chain that costs the farmer, directly, as a rule 8 per cent for the money he borrows, and indirectly very much more.

An effort was made at the last session of the general assembly to simplify Georgia's title system and put it upon a scientific basis. The senate passed the bill, but in the rush of business definite action was not taken by the house.

The Constitution is the proponent of no special title system, the Torrens or any other. But we know that the present method is archaic, costly and bristling with invasions to litigation. In the case of rural credits, it is a positive discon for whatever good the state may derive from that addition to the currency system.

The forthcoming legislature should lose no time in providing for a correction of this slack and long-standing abuse. It may cost a few lawyers a few fees, but it will save the farmers and the people of Georgia hundreds of thousands of dollars and many sleepless nights.

TOLD IN CONFIDENCE.

The fact that the United States supreme court has refused to hold two reporters of The New York Tribune on a charge of contempt of court is creating press comment up and down the land. These reporters had refused to divulge grand jury information which had come to them in confidence. The lower court held them in contempt for so doing. The appellate court reverses, on the ground that the reporters disclosed the information might have incriminated them.

More than one paper has remarked, with point, that it would have been more satisfactory had the ruling of the court been

broader. In other words, if the court had held the newspaper in the same class with the lawyer and the physician, who are both protected by law from disclosing the secrets of their clients.

Often it happens that information comes to a newspaper from a perfectly reliable source, but under such conditions that it is necessary to protect that source to make the information of use in public policy. Here it is a question of law to enable moral and private justice to compel the newspaper to give its informant. If the information is inaccurate or libelous there are plenty of laws offering complainants recourse.

Two great troubles arise with the modern newspaper in handling news of this character. They are the professional "reformer" out for glory and jealous of rivalry, and the "yellow" newspaper that steers just close enough to the border line of truth to escape the libel laws but not to avoid hurting sensitive feelings. To these two may sometimes be added, as has frequently happened in New York city, a thick-headed police force, watching with a jealous eye every move of the reporters and pulling wires in every direction to cover up tracks.

This is not, of course, to forget our old friend, the demagogue, keen enough to use the reporter, but quick to come around and repudiate the story and its writer if it does not "take."

Gradually the courts and the American sense of ethics are working out a code with regard to the newspapers and the latitude they may be allowed. The public is learning to discriminate, too, between the reliable and the unreliable newspaper, and that is a large part of the battle.

## NOT VIEWING WITH ALARM.

There is no cause for anyone in this country, except perhaps the jingoes, to entertain alarm over the diplomatic melées between this country and England and Germany. The headlines may grow even more violent, and yet signify nothing more portentous than a little healthy bluffing on both sides. At any rate, the administration has taken the only stand it could, in self-respect, take with reference to both England and Germany. The Van Dyke incident is a thing apart, and must wait for further developments to determine its proper place in the situation.

What we have done is simply this:

(1) Warned England against incursions use of the United States flag to protect her own shipping. It must be remembered that the use of the ensign of a neutral is a strategy long justified in war, although the ethics of it is open to question.

(2) Germany will also be warned that this country will not tolerate under any circumstances the endangering of the lives of its citizens by German acts of war.

To both countries notes are couched in diplomatic language, but these are an endorsement of determinations that will not fall of its effect on the other side of the ocean.

We tell England plainly that her command of the high seas places upon her an unusual responsibility.

The spectacle is comparable to two boys fighting all over the lawn and suddenly tumbling over and threatening with injury a third, innocent, bystander. The United States objects, and justifiably, to being made the "goat" for the war-to-the-death now going on between the allies and Germany and Austria. That is about all there is to it.

The man who is tempted to get excited must remember that this war is unparalleled in the world's history, and that it must, therefore, be viewed in a light that is unparalleled and met with a course for which there are few precedents. It is a conservative assumption that neither the allies nor Germany care to tangle up with this country at present. When they find out we are in earnest about demanding the rights of the neutral, the atmosphere will clear wonderfully.

The Constitution is the proponent of no special title system, the Torrens or any other. But we know that the present method is archaic, costly and bristling with invasions to litigation. In the case of rural credits, it is a positive discon for whatever good the state may derive from that addition to the currency system.

The forthcoming legislature should lose no time in providing for a correction of this slack and long-standing abuse. It may cost a few lawyers a few fees, but it will save the farmers and the people of Georgia hundreds of thousands of dollars and many sleepless nights.
