COURTS EXONERATED ME, ASSERTS HEAD OF ATLANTA POLICE BOARD

"Hugh Dorsey Says You Settled Indictments by Paying \$500 for Each," Charges Woodward. "Then Dorsey Is a Liar," Replies Fain.

Despite caustic attacks by Mayor James G. Woodward, and bitter denunciation of the "past record" of Police Commissioner W. P. Fain, which the mayor declared was studied with joy rides and evenings spent in gambling dens, Mr. Fain was elected by his friends as chairman of the police commission for the ensuing year at last night's meeting of the board.

The mayor produced two copies of indictments as evidence of his charges, one of which, the mayor declared, charged Mr. Fain with operating a bawdy house. The other was assault and battery upon the person of the madame of the alleged bawdy house.

Mr. Fain emphatically branded all the charges as "lies, and dirty politics."

"Soldier Hugh Dorsey says that these indictments against you, the charges were settled out of court for \$500 each," charged Woodward.

"Then Hugh Dorsey is a liar," howled Mr. Fain.

\$1,000,000 Smuggle Scheme Is Hatched In Atlanta Prison

Grobe Gets Out of United States Penitentiary Just in Time to Get in Again.

An indictment announced in an Associated Press dispatch, by a New York grand jury yesterday of Hugo Grobe, revealed the dream of a million dollar smuggling scheme hatched in the Atlanta federal penitentiary, an attempt to smuggle in from Europe to the prison walls so daring that it staggers the imagination.

The dispatch states that Grobe was charged with the offense of conspiring to smuggle into this country from Germany, the success of which plan he expected to net him \$1,000,000 in pure gold.

Released From Atlanta Pen.

Grobe, formerly a Hamburg-American officer, was recently released from the Atlanta prison at the expiration of a term of years under a former conviction of smuggling opium.

He was a member of the Atlanta authorities every assurance upon his release he intended to lead an excellent life, but the German was awaiting his sitting in his cell perfecting a scheme by which, with the aid of an accomplice, he would smuggle the drug into America again, and on a larger scale than ever, by smuggling opium in from Europe and in potatoes.

Grove's Account.

Grove, it is said, was a retired Hamburg-American officer, and before Grobe was released from the federal prison he was given a job as a waiter in a restaurant in Atlanta. He was awaiting his plan.

79,593 BUSHELS
OF WHEAT IN CANADA

Ottawa, March 9.—A government inquest, the result of which became known to the public yesterday, shows that the amount of wheat and of wheat equivalent in flour and bran in Canada, as of March 1, 1915, was 79,593 bushels, distributed as follows:

Terminal elevators, 2,452,679 bushels; railway elevators, 1,554,240; flour mills, 5,160,340; in transit by rail, 12,571,876 and in storage, 1,785,240.

The result of the inquiry, it is stated, shows that there is no need to be amply supplied to meet all requirements between now and next summer, for food during the next six months. It is recommended that the government should be required thus leaving a balance of 10,000,000 bushels for export and reserve.

BULGARIA FACED
BY THE QUESTION
OF PEACE OR WAR

Course to Be Followed by
Greece Not Yet Determined, Though the King
Favors Neutral Policy.

ITALY IS ON THE EVE
OF DECISIVE EVENTS

Premier Salandra Is Quoted
as Saying Italians Will
See That Destiny of Country
Is Accomplished.

London, March 9.—The operations of the fleet the Dardanelles, now reported to have been reinforced by another battleship of the Queen Elizabeth class, which has been included more ships than mentioned in dispatches, continue to occupy the British people, who always take keen interest in the news.

Reports that three of the fort guarding the narrows, one on the European and two on the Asiatic side, all armed with 14-inch guns, have been silenced to the satisfaction of the British public, who consider that such will force the straits.

In addition to the military and economic importance of the opening of the straits, the question of whether it will be believed it would have an immediate effect not only on Turkey, but on Turkey's neighbors, Greeks already is involved in a constitutional crisis over the Dardanelles. It is reported that a similar crisis had arisen in Bulgaria, where it was said the prime minister had been compelled to resign, and the king, who is on the side of the allies in opposition to the wishes of King Ferdinand, who it is desired to be neutral.

In Greece, Mr. Gounaris has undertaken to form a cabinet to succeed that of M. Venizelos, and to dissolve parliament if that body does not endorse his policy of friendly neutrality to the Allies. He has been received in London, however, that the people will force the Greek government to withdraw from the Venetian zone will be back in office.

Although there is no direct evidence that the king has issued an order to the army neutrality, Rome dispatches express the belief that the nation is in a state of civil war, which is considered highly probable. The new cabinet is expected to favor continued neutrality.

GERMANY IS HOPING
WAR MAY END IN DRAW

London, March 9.—Reuter's Amsterdam correspondent says the Berlin paper "Der Vorwärts" reproduces an article by Professor Paul Rohrbach, weekly. The article, reproduced in the government's view, says that Germany's chief aim is to end the war.

Mr. Rohrbach, who is the correspondent that Frederick the Great was conqueror in the seven years' war, although it failed to gain all the territory and only held his own.

"Professor Rohrbach," continues the correspondent, "thinks that Germany likewise might regard herself victorious if, at the end of the struggle, the Allies' intention to destroy the German army is not realized, as before the war, the same condition as before the war, signaling the end of the war.

The article concludes, "while the advantages of the stop-gap ministry are clear from a military point of view, the disadvantages from the loss of Greece's opportunity are equally clear."

ATHEENS
NOT YET SETTLED.

Athen, March 9.—(Via Paris).—M. Gounaris, departing for Athens, has announced at the request of King Constantine to undertake the task of forming a new cabinet. It is reported that M. Venizelos, who has been summoned to the Theotokis cabinet, has consented to take that portfolio under the lead of M. Gounaris.

M. Gounaris will submit his list of ministers to the king tomorrow, it is understood, and the king will then decide whether the chamber shall be dissolved or if the supporters of the ministry are to be given a chance.

M. Zaimis, who returned yesterday to form a cabinet, but he declined.

KING OBEYED General Staff.

Paris, March 9.—M. Venizelos, former Greek prime minister, is an independent given the Athens correspondent of The Times. King Constantine acted on the advice of the general staff in opposing the policy of intervention proposed by M. Venizelos. The staff advised that an intervention by the Greek army would weaken the military situation on the Bulgarian frontier, which is the chief strategic point of danger in view of Bulgaria's double attitude.

A news dispatch from Athens contains this quotation from The Times published in the Greek capital:

"King Constantine, who is Venizelos, emphasizing the necessity for the convening of the chamber of deputies to vote on the intervention, M. Venizelos, in reply, gave his assurance that he would not insist on the chamber dissolving itself, and that the new cabinet obtained a vote of confidence."

"Further than that, M. Venizelos said he would not insist, as chief of the majority, consent that his party should be allowed to form a cabinet, but he did not declare that he would be compelled to do so.

BULGARIA FACING

ABINENT CRISIS.

"Paris, March 9.—A ministerial crisis similar to that in Greece has developed in Bulgaria, according to news dispatches from Sofia. The general staff is reported to have been overthrown by the supporters of Dr. Ghenev, former foreign minister, because he had been too friendly to Austria against Turkey by occupying Adrianople.

It is reported that Dr. Ghenev, who has declared that such a policy, which was adopted by Bulgaria in opposition to Germany and Austria, would be too adventurous. The result of this was that Dr. Ghenev left Greece more isolated than before, and that the king, who was neutral, she might hope for advantages other than those she would find in Turkey.

Although this information has not been confirmed, it is believed to be well believed in the French official circles that Dr. Ghenev, who has been pronounced for the triple entente, and that Venizelos, who is the chief of the party in Athens when the question of intervention came up.

ITALY ON THE EVE
OF GREAT EVENTS.

Rome, March 9.—(Via Paris).—Premier Salandra had a long interview with Foreign Minister Sonnino and the controller of the navy, who are irreconcilable.

These and other indications lead to a widespread belief that Italy will be on the eve of great and decisive events.

One of the premier's remarks at Gasta, where he went Sunday to inspect

the kind of brown bread allowed in Italy after March 22, Signor Salandra said:

"This is a noble bread. Our soldiers will be the first to be sacrificed and our country will be the first to be sacrificed."

General Salandra, representing the army and navy, thanked the premier for his presence and commented: "I hope to stay; if they tell us to march, we will march; if they tell us to stay, we will stay; the name of the king of Italy."

UNDERWOOD DISCUSSES RAILROAD SITUATION

Democratic Leader Says If Regulation Fails, Government Ownership Will Come.

New York, March 8.—In a speech on the railroad situation before the Spanish Club here today Oscar Underwood, house majority leader in the last congress and now elected a senator from Alabama, declared that "if the railroad situation continues to cope with the vexed problem that confronts us, the people will accept government ownership as the next step ahead."

Discussing the present system of regulating business, Underwood said: "The time has come when the government should aid leaders of industry and agriculture."

"It is not enough for the government to permit these men to rise from the present position and to keep them and their affairs," he continued. "We must do more. We must find a way to social betterment where sound progressivism must recognize that the basic right of the people to be known to it must sometimes be helped and not hindered. We must do more at times assisted and not forever stricken, that we must occasionally say 'You are right' and not always 'You are wrong.'

Adequate Provisions for Capital.

Adequate provision, or capital to maintain and extend the nation's transportation facilities, is the problem confronting the government in its regulation of railroads. Mr. Underwood said: "The present system of regulation is breaking down, in that it fails to give the railroads the finances of the railroads with a view to allowing them property to protect their interests and to keep them maintained to sit in present and future times."

Regulation of railroads, Mr. Underwood said, should take into consideration the railroads, the railroads themselves and those directly interested in the railroads, the country whose commercial prosperity is dependent upon adequate shipping facilities.

"We have undertaken the problem of the regulation of railroads," he continued, "and the government, in its regulation of practices and rates is here and here to stay. Let us stand for wise and just regulation, for the protection of the railroads and regulations regarding rates and necessary railroad facilities both for the present and for the future. As the public interest is the chief, it will be primarily interested in the railroads, their maintenance and development at reasonable rates and equally interested in their regulation."

Revolutions Don't Move Backward.

"Revolutions never move backward, if you are to be successful in your efforts to cope with the vexed problem that confronts us, the people will accept government ownership as the next step ahead. It is, therefore, a matter of great importance that we, in our earnest endeavor to reach a fair and reasonable solution to the problem of regulation, must early do away with possible."

After discussing the difficulties of dealing with the railroads through the varying and conflicting policies of the states and the government, Mr. Underwood said:

"It cannot be denied that monitory control has reduced the rates charged by railroads, but it has also eliminated just discriminations given to favored shippers. But the greater problem remains, that of how to expand and develop these railroads, and to do this, we must measure up with the expanding needs of our commerce under the present system of regulation."

"If railroad investments cannot be made, then the railroads will be threatened with an inevitable breakdown of its transportation system."
