WAR A BLESSING TO THE RUSSIANS

That Is Opinion of Czar's Finance Minister—Prohibition of Vodka Proves Wonderful Economic Boon.

PETERSBURG, April 12.—(Via London.) Opinion was expressed today by Prince L. Bark, Russian minister of finance, that, economically considered, the war has been a blessing to the people of Russia. Discussing financial and social aspects of the conflict in an interview with the Associated Press, Mr. Bark said:

"Notwithstanding the depressing and paralyzing effect of the war, the Russian peasant class is more prosperous than at any previous time in the history of the country."

"It is not difficult to account for this unusual prosperity. By virtue of the allowance made by the government to the families of soldiers, which exceeds the earning power of the soldier, the total income of these families is greater than in times of peace. Thus, instead of feeling any privation as the result of the war, the Russian men and the loss of their services, the people are beginning to regard the war as a peculiar sort of dividend which is putting money into their pockets."

Good Effects of Prohibition.

"What about vodka?" was asked of the minister.

"It is prohibition of the sale of vodka which is primarily responsible for the ameliorated condition of the peasant," he responded. The usage through which all the available earnings formerly dissipated has now been closed and the money is either spent for present necessities or saved for future wants.

"It is not necessary to invent theories to explain why the Russian people should be more prosperous, for the actual fact is that this prosperity is everywhere noticeable. Before the war the average yearly average dividend amounted to from \$10,000 to \$20,000, while in the month of January alone about \$30,000,000 was deposited."

What about the crops?

"The farmers are very fortunate in being compelled to hold their grain in the hands of the government, instead of being able to dispose of it at the highest price of the year. There is every reason to believe the farmers will soon be able to dispose of their grain in foreign markets and at a good advance."

Expenses of War Poised.

Discussing the Paris conference of the allied finance ministers, Mr. Bark said that the conference had considered financial problems arising from the war. Mr. Bark said:

"One result was the formulation of an agreement with the allied governments as to the expenses of the war. In accordance with this agreement, Russia was to draw upon Great Britain, France and America for the purpose of obtaining the necessary funds to carry on the war. This was an excellent arrangement for all concerned, for while Russia is carrying on the war, she is also receiving the necessary capital and our allies are obtaining the more capital supplies."

He also stated that Russia had already arranged a credit of \$125,000,000 in France and of \$125,000,000 in England, which Russia is to use at any time the situation requires. We are on the point of making use of the French credit.

TRUST CHARGE MADE IN GOVERNMENT SUIT

**Witnesses Testify Before Commission
Against Influence of
Corn Products Co.**

Testimony tending to show that a monopoly of the manufacture and sale of glucose, starch and mixed table syrups is maintained through the organization of a trust which unduly restrains trade in these products was given yesterday at the federal building in the civil suit which the government has brought under the Sherman anti-trust law against the Corn Products Refining company and others.

Those who appeared on the stand Monday were E. D. Wilder, president of the Wilder Manufacturing company; J. H. Hinkle, secretary-treasurer of the Garney-Blaquey company; both of Atlanta; Homer S. Pratt, local broker for the Hinkle company, of Keweenaw, Iowa; and J. Williams, of Columbus, Ga.

These men stated that the company and mixed syrups had been sold at a profit until the organization of the trust in 1905. Since that time, however, the trust had cut into the syrups business by forcing the price of glucose upward had compelled several firms to close.

Both of the men with Withers testified on oath that Withers was not fishing when he was arrested by Walker, who had no warrant for his arrest, said Mr. Cochran. "I am convinced that there was no reason for his arrest."

"We do not need his help from

these deputy game wardens and they are invited to attend to their own affairs and keep out of the city park. The police authorities are capable of enforcing city ordinances in the parks without their aid."

"Mr. Bille, lessee of Lakewood Park, informs me that he did not know nor desire the arrest of Mr. Withers, nor did he swear out any warrants."

According to testimony before Justice Jackson, Walker went into the park, which is located by J. Bille and asked to see Withers there. He had some and his arrest followed.
