ELECTIONS IN THE PURCHASING AGENCY

Refusal to Preside Prevents Election of W. E. Cham- bers as Purchasing Agent for the City.

WOODWARD IS ROASTED BY COUNCILMAN SMITH

Declares He Has Contempt for Man Who Can't Take His Medicine When He Is Beaten—Court Fight Pre- dicted.

Retiring to preside over the general election Monday afternoon, when a city purchasing agent was to be elected, Mayor James G. Woodward left the chair and walked out of the council chamber.

The mayor had taken the chair to preside for the holding of elections after four board members had been elected and a nomination was made for purchasing agent, he proceeded to read a message to council in which he declared that because of the illegal manner in which council had proceeded about the election of a purchasing agent he would never preside unless forced to do so by the courts.

The scene when the mayor left the council chamber was one of the most dramatic that has ever been witnessed by the city's legislative body. It was the first time that such an act had ever been committed by a mayor of Atlanta.

Passed Over Veto.

Council had passed an ordinance taking from the mayor the appointment of the purchasing agent. The mayor vetoed the ordinance and it was passed over his veto. Now the refusal of the mayor to preside has the effect of making the election of a purchasing agent for the time being, at least, for so long as the mayor is within the limits of the city he cannot preside when elections are held.

The mayor has said in a statement: "If you wish to force me to hold the election then go into the courts and seek to maintain me. Let us see what the courts will do." This was his ultimatum after he had suggested the resignation of several of the council members.

Four members of city boards had been elected, the mayor vetoed them. All looked angry and pensive.

"I nominate W. E. Chambers for purchasing agent," said Councilman Smith from the ninth.

"I second the nomination," called out several other councilmen.

Mayor Resigns Statement.

The mayor asked for the reading of a request for the clerk to call the roll, which he refused to do.

"When he had finished, Councilman Smith, of the ninth, arose quickly to his feet and called out: "If your honor please the city attorney."

Richardman Regalada, the mayor pro tem, will take the chair, called out the mayor, either by resignation or resignation of Councilman Smith.

"That paper which the mayor has read is an official document, and I move that it be sent back to him. There are things in it that are not true, and I will call you to account for this council, we cannot sit quietly here and let a man try to insult the city by calling his way when we know that he is wrong. He undertakes to set up his own way, and then when we do not agree with him, he denounces us as traitors. He says we cannot take his medicine like other men have to do when he is whipped. I have a remedy for that. I will call him to account for it."

Woodward said that he would not do it. If he would let him have a copy of the ordinance, he would give it to the purchasing agent with one man in power, and the man who cannot take his medicine, mean ways whenever he is wrong.

Mayor to Send Paper Back.

The motion to send the paper back to the mayor was adopted with a viva voce vote of two yeas and one nays, voting "no."

The motion of Councilman Smith the city attorney was instructed to render an opinion on the legality of the ordinance which was adopted by the council. The purchasing agent's ordinance and report the same to council when it meets again in adjourned session next Monday afternoon.

The mayor claimed that the amendment to the purchasing agent ordinance raised the salary of the agent from \$10,000 to \$12,000. DATE FOR HEARING OF FRANK'S OFFER

THE PRISON COMMISSION ON Monday Decided to Hear Petition of the Prisoner on May 31.

The prison commission yesterday set a special date—May 31—to hold the Leo M. Frank hearing on the plea for commutation, assuring final action on the appeal by Governor Slaton, unless he himself passes it on to his successor, Governor-elect H. E. Harris.

The early date was arranged largely at the request of the doomed man's counsel, but also because of the heavy week which the prison commission has before it on the date of its regular session, June 7.

The date was set at an informal conference of R. E. Davison, chairman of the prison commission, with Harry A. Alexander, attorney for Frank.

The entire week, if necessary, will be devoted to the hearing. Whether Solicitor Hugh M. Dorsey will take part in the hearing is still a matter of speculation.

More than 1,000 letters pleading for Frank were received by Governor Slaton Monday morning, two of them being from United States Senator W. E. Borah, of Idaho, and Pittman, of Colorado; Senator Newland, of Pennsylvania; Haffner, of the rock, former ambassador to France; Senator Reed, of Missouri; Senator C. D. Thomas, of Colorado; Senator Newland, of Nevada, and Governors Cavanaugh, of Pennsylvania; Haffner, of West Virginia, and Ferris, of Michigan.

The governor has received more than 7,000 letters bearing on the case, many of which must necessarily go unread. Leo Frank himself receives an average of 1,000 daily, which are read by himself and his wife.

GERMANY IS CAUTIONED ABOUT HER SUBMARINES

Count von Bernstorff Lets Berlin Know the State of American Feeling and Ad- vises Great Caution in At- tacking Merchant Vessels.

Washington, May 17.—Germany is expected to answer the Lusitania note before the end of this week. Ambassador Gerard called the state department today that he had read the document which he had received from the minister, and that an early reply would be forthcoming.

The ambassador was given no indication of the feeling of the German government. He was assured merely that the subject would require consideration by high officials, and that a reply would be ready soon. As the press had not been permitted to publish the text of the note, the ambassador also was unable to report on the state of public opinion.

In the meantime both Count von Bernstorff, the German ambassador, and Dr. Constantin Zimmerlin, the Austrian ambassador, are understood to be actively endeavoring to prevent a rupture of friendly relations between Germany and the United States.

Neither of the diplomatists would discuss the subject today. Dr. Dumba, however, of Vienna, who is in contact with other officials of the state department. It is known that he discussed the matter yesterday in connection with the sinking of the Lusitania and the sending of the American note, and it is understood that Secretary Bryan approved President Wilson of the substance of the conversation. Later Dr. Dumba conferred with Count Bernstorff.

Germany and Austria Cautioned.

Both the Austrian and German ambassadors yesterday were cautioned by the state department regarding their governments' suspension of submarine attacks on passenger ships while the diplomatic situation remains unsettled. The German ambassador was cautioned to exercise extreme care lest the sinking of another ship with American lives aboard may lead to a rupture of the relations of the United States with Germany.

Austria is watching with much interest the situation in the Atlantic, and is confronted and her influence is being used in the direction of assisting in a peaceful settlement. Neither the German nor the Austrian ambassador is informed yet as to the policy the German government finally will follow. That Count Bernstorff will advise the adoption of a policy by his government which will satisfy public opinion in Germany is understood to be the hope of the state department.

The general expectation here is that Germany will retract her willingness to abandon her present submarine warfare on merchant ships and follow the maritime practice today by which she influences the allies to permit the shipment of munitions to civilians in belligerent territory.

Talk of Protest to Britain.

In there has been some consideration given to British quarters here to the advisability of making a protest to the British government against the actual operations of the fleet in enforcing the blockade of neutral countries. It is never has admitted their right to interrupt trade with neutral countries unless it is proved to be of a contrary character with an ultimate enemy destination. Many non-contraband goods bound for neutrals are said to have been detained and the sending of such goods to neutrals is well-informed opinion tonight.

HOLD TO COTTON.

Every Chamber of Commerce, every Board of Trade, every civic organization interested in the progress and upbuilding of the south should at once send a telegram of protest to the United States postoffice department in Washington against its proposed substitution of jute sacks for cotton duck in the handling of freight mail.

The evidence of the fact that the national postoffice department is about to substitute jute, a foreign product, for cotton, which it has from time immemorial been using, lies in the notice to that effect which has been given to possible bidders on jute bags.

The letter to the press, signed by the government purchasing agent, reads:

"It is advised by the fourth assistant postmaster general division of the department of the use of mail sacks for freight shipments and substituting therefor jute sacks. Will you please advise me as to the stock sizes of jute sacks manufactured by you that would be suitable for this purpose, also the price of material and prices on a 1,000, 5,000 and 10,000 lot.

It is well known that the ordinary mail sack is made of cotton duck; yet here is a proposal coming direct from the postoffice department itself to abandon the use of the cotton duck sack for a large proportion of its business, and to substitute the jute sack for it—a direct reversal of the policy which the newspapers, the business men and the statesmen of the country have been preaching for the past year or more. It is the policy of supporting the home industry where all other things are equal, and in this instance the advantages can be shown to be in favor of the home product.

We cannot believe that this matter has come to the attention of Postmaster General Burleson: It is difficult to conceive that he would have given such an order, and we shall continue to give, until notified to the contrary, that when it is brought to his attention, he will condemn it.

It is not long since the national postoffice department took up the proposal to use cotton twine in place of jute and advertised widely for bids upon large supplies of it.

It is one spoke more emphatically in praise of that action of the Constitution, which had previously adopted cotton twine in its own business. We have not been informed as to whether the substitution of cotton for jute twine has yet been made, but we took it for granted that the department would unquestionably carry out its announced intention at the earliest possible moment.

Knowing departmental views upon the subject, we can but feel that some mistake has been made in giving this notice to substitute jute for cotton mail sacks. It is error, however, which will do us no harm, for the new cotton twine is made in this country, and it would probably be difficult to set it aside.

The Constitution believes that it will only be necessary to call the attention of Postmaster General Burleson to what is about to be done, to bring about a reversal of this bad business policy. It can be forcibly brought to his attention, if the commercial and trade bodies of the south will act promptly in entering their protests.

It is a question of business more than it is of sentiment. The southern trade bodies should take it up on a business basis. We feel confident the response to their representations would be prompt and satisfactory.

BACK ON OUR FEET AGAIN.

Atlanta's bank clearings of \$13,972,000 for the week ending Saturday, May 15, were three-fifths of one per cent greater than for the same week of the preceding year. Significance of this announcement lies in the fact that for the first time since

the outbreak of the European war we have gone ahead of the same week of last year.

Coincident with the southern cotton crisis and the general business depression following the outbreak of hostilities in Europe, Atlanta's bank clearings, along with those of every other city in the country, were seriously affected. Week by week the situation has grown better, getting nearer and nearer to normal. Now Atlanta is again on top, with a steady and substantial growth assured.

It is only a few weeks since restoration was announced in Atlanta's postoffice receipts; now her bank clearings have come back, and the combination tells its own story. We are back on the business ladder and are mounting it, along with most of the rest of the country. Better business has come to lay.

TRIFLING WITH ITALY.

If the most astute of Italian statesmen had started in to bungle Italian plans with regard to entering the European war he could not have succeeded half so well as some one has done—perhaps there were several involved in it—without intention.

Was it Prince von Buelow, who, up to this time, has outtalked and outstatedmaned Italy? It looks very much as if the shrewd German politician has been the cause of that delay, every day of which has meant great difficulty for Italy when the final crisis comes.

Italy began to mobilize her armies and recruit them to their war strength almost simultaneously with the declaration of hostilities. It was known in the early days of the war that Italy had fallen away from the triple alliance.

We may take it that in the early days of the war Italy was merely preparing for eventualities. But for the last six months there hasn't been a day but it was apparent that Italy's ultimate participation was inevitable. It has not been a question of which side; that has never figured. The opportunity to get back her provinces, lost to Austria more than half a century ago, was too good; the desire to participate in whatever reformation of the European map may follow peacemaking was an incentive almost equally great. It might be said Italy's name was written as a combatant simultaneously with the German declaration of war.

The people of Italy have been for war from the very start. Favoring participation almost at the outset, this sentiment has grown until it has become a public demand for war, threatening revolution and the establishment of a republic as an alternative.

Thus has pressure been brought to bear upon the throne, small as is the only power left to it, its very life is at stake. Tired of waiting, the Italian people have expressed themselves in riots and public outbreaks; the army, itself inclined to war, has had preliminary clashes on the Austrian frontier in advance of the declaration now momentarily expected.

While the Italian government has thus far permitted itself to be hoodwinked by German diplomacy; while it has pretended to barter with Austria its semblance of a neutrality which the Italian people have never recognized or sanctioned, Austria and Germany have been preparing to meet the onslaught when it does come. Six months ago Italy might have sent an army of 1,000,000 men on a direct march to Vienna almost without obstacles, except such as could hardly be brought against it; today they will find trenches dug across the whole frontier, rapid-fire guns set and ready for action, howitzers with fuses applied, piles of dug mines set and barbed wire entanglements everywhere round about. With the heavy demoralized troops their forces both in western and western fronts, Germany and Austria needed this time for preparation against Italy and they get it.

Italy's war plans may, doubtless will, meet with ultimate success; but she has lost valuable time. If she had followed the inevitable six months ago we might have seen the end of the war today; it would at least have been in sight.

We do not undertake to say at this distance whose is the responsibility, but somebody has blundered. And every day's delay makes matters worse for Italy and helps Austria and Germany just that much.

What was formerly called a defeat in battle is now listed as "retirement for strategic reasons."

The world-wonder is how Italy can preserve her equilibrium on such an unstable fence.

Mr. Perkins is quoted as saying that he is "an unshaken progressive." But wasn't he the Plum Tree of the original campaign?
