SLAUGHTER OF LUSITANIA PASSENGERS CALLED "SELF-DEFENSE":

Wilson Is Resolved to Have Reparation For Killing of Americans on Lusitania Even at Cost of Clash With Germany

LEO FRANK'S PLEA FOR COMMUTATION TO BE HEARD TODAY

Solicitor Dorsey Has Not Yet Announced Whether He Will Make Oral Argument Against Clemency.

COMMISSIONERS HERE READY FOR HEARING

Large Number of Delegates Will Appear to Make Appeals for the Prisoner. Chicago Party Arrives.

PLEA FOR FRANK.

The 240,000 women I represent do not argue the innocence or guilt of Leo Frank. Our plea is purely humanitarian. We feel that there is an element of doubt in the case, and we are supported by the expression from Judge Roan. We think that Frank would be given time to prove either his guilt or innocence. We plead that Georgia should not slay a man who is likely to be innocent of the crime with which he is charged. It is no time to quibble about the technicalities of the law.—Mrs. M. Delaney Fisher, of Chicago.

Georgia's prison commission will meet this morning at 10 o'clock at the capitol for the purpose of giving a hearing to the petition for commutation from death to life imprisonment of the sentence of Leo M. Frank, condemned to die for the murder of Mary Phagan.

The length of the hearing is undetermined. Frank's attorneys believe it may be finished in a day, but others are of the opinion that it may last for several days, as there will be a number of delegations present to plead for the prisoner, and prominent Atlantans are also expected to make appeals. When the hearing opens the defense will introduce the affidavit made by Judge L. S. Roan, now deceased, who told of the hostile atmosphere of the trial, and the reasons why he urged that Frank be not present when the verdict was rendered.

Judge Roan's letter.—It is also understood that a letter will be presented which was written by Judge Roan, in which he reiterates his doubt as to Frank's guilt and urges clemency.

Then William M. Smith, Conley's lawyer during the trial of the Phagan case, is expected to testify that he now believes the prisoner innocent and his former client guilty. The records of the court in the different appeals made for Frank will also be presented.

The prisoner will be represented by ex-Congressman William M. Smith, who will review the case and will stress the doubt as expressed by Judge Roan, by two state supreme court judges and by two United States supreme court judges.

Desperate Efforts Made By Austro-German Forces To Beleaguer Przemysl

Teutons Are Striving to Cut Off Fortress and Release Their Armies for Operations Against the Italians.

BIG HUMAN SACRIFICES MADE BY TEUTON ALLIES

But Their Progress Is Extremely Slow, as the Russians Have Brought Up Strong Reinforcements. Sharp Fighting on the Western Front.

London, May 30.—Around the great fortress of Przemysl a mighty battle is still raging. The Austro-German armies are making a supreme effort to cut off the stronghold and free three armies for operations against Italy and the allies in the west.

Although great human sacrifices are being made, progress lately has been extremely slow, as the Russians have had time to bring up large reinforcements. North of Przemysl the Russians appear to be more than holding their own, but in the southeast, the Austrians and Germans have pushed back, way and now command with their artillery the railway between Przemysl and Cnococh, which runs just south of the main line between Przemysl and Lemberg. From Lemberg the Russians draw a large portion of their reinforcements and supplies.

The German official statement says that after a ten-hour artillery attack, most of the year canal the allies were repulsed.

FIGHTING BLOODY RUSSIANS REPLY

THE STATE IN BUSINESS.

Georgia is in business just the same, in a measure, as is any firm or corporation. It collects money from the citizen for the use of the state. It collects taxes, and it disburses that money in payment for what it needs. What reason is there, then, for the state putting itself above and beyond the ordinary laws of business? Why should there be one rule for the government of the citizen in business transactions and another, more and more advantageous one for the state?

We are moved to ask these questions as the result of an opinion of the attorney general in which he holds that there is no liability on the part of the state agricultural schools, or other state institutions, for the payment of interest on past due accounts.

Isn't the state setting a bad example to its citizens in assuming this attitude? We are forcibly reminded in this connection that the state itself insists upon interest payments upon overdue taxes, and it looks very queer to exempt the state from interest, or, thereabouts, is always the last day for the payment of state taxes, and the unfortunate citizen who, through inability to pay or other cause, delays his settlement, must add 7 per cent per annum to the amount or suffer the same penalty as if he had failed to pay altogether.

It is difficult to conceive upon what theory a decision of this sort was rendered. Everybody understands, of course, that the state is sovereign and cannot be sued for debt or anything else. But that should be the only reason why the state should conform to well established business customs. The state cannot borrow money without paying interest on it, and it should be just as ready to meet interest payments in those ordinary cases where the business world recognizes the justice of it and where the citizen would be required by law to pay it under similar circumstances.

We would respectfully suggest in the interests of the state's good faith that here is a decision which should be reviewed and made to conform to well-known and recognized business practice—if not to common honesty.

Dr. J. L. White, pastor of the Baptist Tabernacle, in his Sunday night sermon placed the blame for crime in Atlanta upon the "stealing dog and cat fight at the city hall."

For this, however, he gave the police credit of clean bill of health, and declared that he did not know personally the clerk and file of the department, but that Chief of Police Beavers was his friend and that he believed Chief Beavers would be ready to go to the stake and be burned tomorrow, if necessary.

"When he made this statement," he asked, "Why don't you say Amen?" "Amen," said a dozen or more voices. "When he laid the blame upon the 'city hall family row,' which he declared, made him sick, he left upon Mayor Woodruff's doorstep the accusation of 'racketeering' to be major rather than to be right."

"There is one man in town," he said, "who would rather be mayor than to be right. Always he says that he will not yet when he was brought, the other day, face to face with impeachment, he said, 'All right, I'll go, but that he had heard a good deal about him.'"
