THAW NEVER INSANE, SAYS DR. BANCROFT

Expert Alonist Declares That White's Slayer Is Not a Paranoiac.

New York, June 29.—Dr. Charles P. Bancroft, head of the New Hampshire State Hospital for the Insane and a member of the federal commission which examined Harry K. Thaw during his sojourn in New Hampshire, yesterday on the witness stand today that in his opinion Thaw was not insane, but always had been sane.

Dr. Bancroft testified as an expert witness in the jury proceedings to determine Thaw's mental condition. Dr. Bancroft said, was not the product of a systematized delusion such as characterized the true paranoiac. The killing of Stanford White, he said, appeared to be a spontaneous, impulsive act, growing out of a condition of mind of Thaw to enter and slay, which was the final culmination of a series of circumstances that had been bearing down on him a long time. It did not seem a type of paranoia, but was due to jealousy of Mr. White, set to a diseased condition of mind.

Dr. Bancroft knew that White had been antagonistic to him in an unpleasant way. He wanted to get even with White. His act was the product of a sane mind, which, after he had indulged in champagne, suddenly lost control of himself.

Then you believe Thaw never was insane? Another reason for my be-

lieve in that Thaw expressed regret for his deed. A paranoiac never expresses regret. He continually tries to justify the deed and no amount of persuasion can convince him he has done wrong. Dr. Bancroft said he had given Thaw a final three-hour examination last Sunday. There is not a doubt or suspicion in my mind as to this man's sanity. Dr. Perry Hickock, of Washington, D. C., president of the American Society of Medical Jurisprudence, testified that he had examined Thaw at the Madison jail some months prior to Thaw's escape, as well as in New Hampshire. Dr. Charles K. Mills, of Philadelphia, another witness, who said he had examined Thaw at various times in connection with previous proceedings and recently in New York, testified that he had found him sane. Dr. Mills was still on the stand when adjournment was taken until tomorrow. It is expected that at the conclusion of his cross-examination Thaw's attorneys will rest their case.

In the city court he brought back a conviction for a term of six months. The trial was held and he was bound over to the superior court to appear at the October term for co-venturing. The bond was placed at \$100. He made the bond and was released.

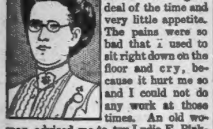

HE LIFTED THEIR EYES AND SUBMERGED HEADS

Noted Pathologist Tells Jury How Smith Drowned Brides in Bath Tub.

London, June 29.—At today's session of the trial for murder of George Smith, husband of three wives who died in their baths, Dr. Spillbury, who testified that the water was turned off and the door locked, said that the effect of a sudden fit or fainting spell on a person in a bath, regarding Alice Barnham, one of Smith's brides, drowned in her bath tub at Blackpool, Dr. Spillbury declared it would have been impossible for a person of her size to have been in such a condition submerged in either a sitting or a lying position, in the bath tub produced in evidence.

Referring to the prisoner's evidence that he had found the woman lying on her left side in the tub, the physician replied: "If this is true, it would have been impossible for her arm to have been bruised as it was found to be."

Both Dr. Spillbury and Dr. Wilcox, another expert, expressed the opinion that the deaths of all three women were consistent with their legs having been lifted and pulled while they were in their baths and their heads barely submerged. Dr. Wilcox said he had conducted none of the deaths was consistent with accidental causes.

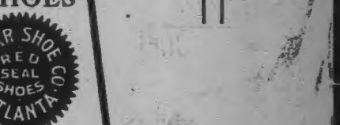
