DESPERATE CONDITIONS IN MEXICO CITY ARE DESCRIBED IN DISPATCH CABLED TO THE UNITED STATES GOVERNMENT.

MOBS ARE SEIZING FOOD WHEREVER IT IS FOUND

No Mention Made of Attacks on Foreigners—Entire Garrison Withdrawn to Aid Zapata Army in Opposing Carranza Forces.

Washington, June 26.—Desperate conditions in Mexico City, with uncheckered mobs rioting and looting are described in a dispatch cabled to the United States government tonight from Vera Cruz by a courier who left the Mexican capital last Friday, June 25.

When the courier started virtually the entire garrison had been withdrawn to join the Zapatistas on the outskirts of the city opposing the attacking Carranza force under General Pablo Gonzalez. Gonzalez had been driven back with considerable loss, but was waiting for reinforcements coming up from Vera Cruz before re-entring the city.

No mention was made of attacks upon foreigners, so officials assumed that they were safe. News stories had been located, the dispatches said, and great mobs were rioting and seizing food wherever it was to be found.

Dispatches forwarded to Wilson, immediately to President Wilson, at Corbush, N. H., and the situation which had been reported by the United States Secretary Lansing when he returns tomorrow from Amberst, Mass. The Mexican capital has been cut off from communication with the outside world by wire and rail for twelve days. The last previous word from there had come from a dispatch from the British charge agent sent by courier, who left the city June 23, two days before the dispatching of the messenger who brought the reports received tonight.

At that time conditions were only less deplorable than the latest dispatches described them. The dispatches are believed to be correct, and although poorly equipped for battle against Gonzalez's well-armed and plentiful supplies with ammunition, are preparing to be evacuated before leaving the capital to Carranza.

Yearning to Fight. Other reports to the state department from Vera Cruz and other train leaders of Carranza troops left there yesterday in readiness for any emergency available man, it is understood, is being rushed to the scene.

Officials here believe the fighting will be carried into the capital itself, endangering the lives of foreigners. The probable course is being taken to take steps to protect the foreign colony.

Dispatches to the Carranza agency from Vera Cruz last night announced that a special train loaded with supplies had been sent to General Gonzalez today and that the Carranza army among the poor of the capital when the Carranza army entered. According to the dispatches, the Carranza army bought in the interior of Mexico at \$25 a ton and sold at \$100 a ton.

Department of justice officials said it is known today that they had no reason to believe that the Carranza army is implicated in the alleged Carranza revolutionary plot.

HONORS TO HUERTA. Washington, June 26.—When Secretary Garrison today reported a review held in General Huerta's honor at El Paso, Texas, and that Mexican Huerta had been a dinner guest of Colonel Morgan, he telegraphed Major General Carranza, commanding the border forces that he thought no honor should be shown to Huerta in Huerta's statue.

General Panon at once replied that review had been in Carranza's honor. Mr. Garrison did not ask about the restricted dinner, but sent general instructions to General Panon to guide army officers in their relations with Huerta's statue. It manifestly meant that Mr. Garrison, commenting on Huerta's official border reports, "for one branch of the government to be looting and setting a man under arrest by another branch."

THREE MORE MEXICANS ARRESTED AT EL PASO. El Paso, Texas, June 26.—Three more arrests on charges of conspiracy to violate United States restrictive laws were developments in the Mexican situation here today. The arrested were Carlos and Frank Alderete, brothers, who were arrested on the spot making a total of six arrests since General Victoriano Huerta was detained Sunday.

In addition to the general charge the arrests brook no delay in the chasing and inhibiting hopes on their march east of El Paso. Their case will be called for preliminary hearing tomorrow together with the case against Huerta, General Carranza and General Obregon.

It was established today that General Huerta's army is being held by the military authorities at Juarez. It was understood, the Villa authorities had blamed the Carranza army of evidence alleged to connect them with the recent Carranza revolution, but had agreed to a suspension of sentence. Whether Huerta would be held as a war prisoner or as a political fugitive was uncertain.

Candler Will Today Sign and Deliver \$3,500,000 Check

Single Check on New York Bank and Biggest in State's History Will Pay for the Entire Issue of Georgia Bonds.

Atlanta, June 26.—The check which will pay for the entire issue of Georgia bonds, this morning, a check on a New York bank for a cool three million five hundred thousand dollars—and a few dollars over—will be delivered to Mr. Candler tonight at a short while ago, his bid being the best that was offered.

Mr. Candler stated at the time he made the bid that he was not interested in representing any syndicate, but was just buying the entire issue of bonds as an individual and for himself.

When Mr. Candler presents his check for the three million five hundred thousand dollars it will be the largest single check ever received by the state, and it will probably be the largest individual check ever issued in the state.

The entire new issue of state bonds will be delivered to Mr. Candler when he lets go that big check on July 1, 1915.

Wages to Be Advanced. Connelleville, Pa., June 26.—W. J. Maney, president of the Connelleville coke operator in the Connelleville region, announced today that the wages of all his employees would be advanced July 1 to \$1.00 a day, the highest ever paid in the region. Several thousand men will be affected.

Dangling Corpses And Hungry Folks Common in Mexico

Trip Through Once Prosperous Section Reveals Scenes of Death, Illness, Ruin and Human Misery.

Jalapa, Mexico, June 24.—(By Mail to New Orleans, June 24.)—Bodies of men hanging from trees and telegraph poles, not in great numbers, but sufficiently conspicuous to make the landscape lurid; crowds of hungry women and children crowded into freight cars or huddled beside railway stations; destroyed bridges, wrecked trains and entire villages deserted or ruined were among the incidents observed today on a journey to Jalapa from Vera-Cruz, sixty miles from General Carranza's headquarters. The trip was through what once was one of the richest sections of Mexico. Everywhere it now presents scenes of illness, ruin and human misery.

Bodies dangling from trees or telegraph poles, hanged first by one faction and then by another as a warning to the many that no quarter was to be expected, were reported by Americans arriving from Oaxaca and interior points. Two such bodies were in full view of the passengers on route here from Vera-Cruz.

Another incident typical of others of almost daily occurrence was the finding of a train of a dozen men and women who recently had been killed. A trainload of Carranza soldiers with women camp followers had run onto the rails here, which the rails had been removed by Zapata's forces. The bodies of the soldiers and women on top of the train fell into the river below. About forty were injured.

JEWELS STOLEN HERE FOUND IN CINCINNATI AND NEGRESS CAUGHT

City Detective John Black left for Cincinnati, Ohio, last night to bring back to Atlanta Mattie Lester, negress, arrested here by request of the Atlanta police, on a charge of complicity in a long string of jewelry robberies of north side residence, including the residence of Kewell Gay, W. B. Swabrock and Mrs. Seymour, 426 West Peachtree street.

Mattie Lester was captured by the Cincinnati police Wednesday, and according to dispatches from the Ohio city, over \$2,000 worth of jewelry, including many fine diamonds, was found in her room at the negro boarding house where she was stopping.

Detective Jim Doyle, who worked on these robberies for several months, and some time ago they arrested a negro by the name of Arthur Sykes, in Atlanta, who was connected with the robbery and has recovered about \$2,000 worth of jewelry here, much of which has been returned to Cincinnati. Sykes is being held here.

The Cincinnati police state that the negro held under suspicion here told of the whereabouts of Mattie Lester, who was captured here. This negro admitted had helped him in the robbery.

Washington, June 26.—(Special.)—It is reported here that Charles Driver, reported lost on the ill-fated Armenian, is brother of L. P. I., England, and nearly a score of American muleteers aboard are reported lost, according to messages to the state department today from John S. Armstrong, Jr., consul at Bristol.

Two of the men in all were lost and one injured.

GREAT CROP OF GRAIN RAISED IN DOUGHERTY

Corn Crop to Be Bumper One. A Ready Market for Wheat.

Albany, Ga. June 30.—(Special).—After harvesting the heaviest crop of corn ever made in south Georgia, the farmers of this section are beginning to wonder what they are going to do with a crop of corn that will undoubtedly overabound any production of former years. It is now certain that the corn yield will be of bumper proportions. Never have the fields been in finer condition. There has been an abundant rainfall, though it has been so distributed that the fields could be kept free from grass. The appearance of the fields is that they could be desired.

To this must be added the fact that the acreage is by many thousands of acres greater than ever before since farming began in this section. If the record corn crop in acreage, and in production per acre, as better methods are used, the total production of corn is generally estimated that the increased acreage is from 25 to 40 per cent in this section of the state. A natural outgrowth of the increased acreage of the grain crops has come a large increase of the size of swine herds on south Georgia farms. As a rule, the farmers are buying blooded stock. At a recent sale of registered hogs and boars in Albany the prices ranged from \$75 each for young sows with litters only a few days old. Many of the sows were bred by a dealer who had bred in brood sows and boars during the war. The farmers say that while they will get some of the corn surplus they expect to have, they do not expect to market it at the higher prices. The prices of hogs and boars, disposing of their hogs as "corn hardened porters, sure to command the highest prices. This is the first year since the civil war that wheat in carloads has been shipped from southwest Georgia counties, in some of which yields of forty bushels an acre were reported. The wheat found ready sale at good prices, but a little under the quotations for best northwestern wheat.

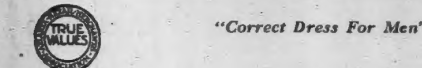

TRIBUTE TO WILSON PAID BY HOKE SMITH

Senator Says President Stood Behind Regional Banks in the South.

Senator Hoke Smith spoke before a joint session of the house and senate yesterday morning from 11 to 1 o'clock.

At one time during his speech he paid a glowing tribute to President Wilson and said the president would be the democratic nominee without opposition and would sweep the country.

He gave all the salient points about the regional bank law and demonstrated the benefits were being operated to protect the country from a money panic.

"An effort was made," he said, "to keep the regional banks out of the cotton growing states, but President Wilson stood behind the south."

He spoke at length of the agricultural extension bill, said that much was being done by the national government to help the farming interests.

"The consumer pays two dollars," he stated, "for every one dollar that the farmer gets. Where is that other dollar? We intend to get it back by having the consumer get the producer."

He said that a great good had been done the cotton industry by the bill regulating the cotton exchanges of the country.

He spoke of the war insurance bill which, he said, had caused the insurance companies to raise normal rates.

Speaking of the war in Europe, Mr. Smith said that he had no right to place an embargo on American goods shipped to neutral ports and that he was in favor of stopping shipping hazardous and irreplaceable goods if the embargo was not lifted.

"If we can get the democratic party back in this country," he said, "you will see cotton selling for the best price since the close of the civil war of fighting."

Why a Man?

Plans for the consolidated Commercial High school for boys and girls have been completed, approved and accepted by the building committee of the board of education, and construction of the building will begin as soon as the materials have been assembled.

Mrs. Annie T. Wise, who really initiated the Commercial High school for girls in Atlanta, and whose splendid service at its head has done more than anything else to vitalize this branch of education in our school system, was appropriately consulted as to the plans of the building.

Her twenty-three years of experience in high school work in this city, after graduating with unusual honors from the Girls' High school; her survey of high school work in the schools of the north and northwest, and her study of secondary educational methods in Germany and France, equip her, as perhaps no person in Atlanta is equipped, to know what is needed in the consolidation and direction of this new high school.

The school will provide for the housing of more than 750 pupils; of these, there will be over 500 girls, and about 200 boys. This requires a faculty which includes 16 women, according to the plan decided upon by the board of education, to teach in the English Commercial High school, and five men attached to teach in the business department of the Boys' High school.

At a meeting of the board of education, held Tuesday, the suggestion was made that a strong man should be obtained as principal of the new school, as it would be the first high school in Atlanta for both boys and girls.

Why a Man? Are the qualifications necessary to direct such a school limited to men? Why not a strong woman, if one can be found? Why, if there are 500 girls in the consolidated high school, and a faculty of 16 women teachers, should a man be placed over the entire school, when there are only 200 boy students?

How long will it take Atlanta to shake off the shackles of tradition pertaining to sex governing strength or efficiency, in any profession, especially in that where women are not predominant, but are more and more being called to lead?

The suggestion made by a member of the board, that there is a woman now connected with the school system, who can make the new combined high school a success, is timely. If it were necessary to go out of our school system to find such a woman there might be some reason for looking for a strong man.

But having a woman whose experience and ability have been tested and proven, by many years of efficient service, the undertaking should be entrusted to this woman.

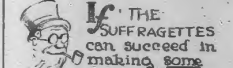

Legislation of All Kinds Suggested in Measures Introduced Wednesday.

A third large batch of bills were introduced in the house yesterday, swelling the total number now pending there to 232. This is declared a record-breaker by Clerk John T. Bouffalant.

One of the new bills seeks to strengthen the tax equalization act, while another would repeal the act.

Mr. Johnson, of Gwinnet introduced a bill to require all persons engaged in business and firms to give in a taxation all notes and accounts.

Mr. Parks, of Leon, offered a bill which would repeal the bill that was passed last summer for the equalization of taxes in the different counties.

A bill which may cause a ffit in the committee and probably on the floor of the house is one introduced by Mr. Edwards, of Tattler. The bill provides that convicts be appointed to the various counties according to the number of roads in each county. A similar bill was introduced in the senate but failed to pass the house.

To Abolish Fee System.—The annual estimate of the fee system and place all county and state officials on salary.

Mr. Runkin, of Dooly, introduced a bill giving the general assembly the right to abolish the office of any county tax collector.

There will be no more giving out in Georgia if a bill introduced by Mr. Brinson, of Johnson, becomes a law. The bill prohibits the giving of relieving of tips in any hotel, restaurant or any railroad train.

A bill introduced by Mr. Pickens, of Clayton, makes a radical change in the state public school system. It provides for the election county school superintendents by the state board of education. Under the present law superintendents are elected once every four years by the people.

Secret Ballot Bill.—To safeguard the ballot in all elections is the intention of a bill introduced by Mr. Neill, of Muscogee. The bill provides for a secret and private ballot at all elections held in the state.

Senator Hoke Smith spoke for two hours to a joint session of the house and senate.

Senator Thomas W. Hardwick will introduce the general assembly on Thursday, July 8, at 11 o'clock.

It is expected that the speaker will announce the outstanding committee of the house Friday morning. As soon as this is done the holding of committee meetings in the house will begin. The large number of bills already introduced will keep the members busy for several weeks. And there are more to follow.
