## Letter From Frank Reaches Brooklyn After His Death

Tells Aged Mother of His First Meal With Wife Since He Was Attacked by Prisoner

(By Associated Press.)  
 NEW YORK, Aug. 20.--Frank's mother today made public the last letter she received from her son. The letter reached Brooklyn yesterday having been written on the night of August 15, the evening before Frank was lynched. His words:  
 "I am sitting up in a rocking chair as I write this. I am very much stronger. At dinner today I sat to table with my dear Lucille."  
 "I have been sitting in a chair for an hour or so each day for the past few days. I am gradually learning to walk after the long stay in bed."  
 Frank added that his wound was healing rapidly and he was able to move his head pretty well. His conclusion:  
 "Give my regards to all enquiring friends. With much love to you and all, in which Lucille joins me."  
 Mrs. Frank in her talk with reporters today, was asked if she forgave the men who lynched her son.  
 "Do not ask me whether I forgive the murderers of my son," said Mrs. Frank. "Perhaps some day I will be able to answer that. Just now I can only quote Leo's favorite passage from the Scriptures. It was:  
 "'Father, forgive them, for they know not what they do.'"  
 "I might add, 'but they will some time.'"

 NEW YORK, Aug. 20.--Prominent Christians and Jews met here today to discuss plans for aiding Georgia to apprehend the men who lynched Leo M. Frank.  
 Isadore M. Levy, member of the board of education, who is interested in the movement, said a temporary organization had been effected and within a few days a strong appeal probably would be made to Governor Harris.  
 Cyrus Adler, chairman of the American Jewish committee, said he declined to work with the committee and did not believe his committee would aid in the matter. He said he thought the hunt for Frank's slayers was a matter for Georgia authorities.

## NEGRO MAIL CLERK IS HELD ON THEFT CHARGE

Big Collection of Stolen Articles Found in Home, Say Inspectors

In the office of Postoffice Inspector R. E. Barry at the federal building is a collection of stolen articles ranging from a Swiss watch to a side comb, which the inspectors found in the home of C. B. Florence, a negro mail clerk, who is under arrest.  
 Florence lives in Albany, and his run is on the Atlantic Coast Line between Albany and Thomasville. He admitted having most of the goods, and inspectors said his operations had covered about two years.  
 His arrest at Albany followed his attempt to sell a box of cigars which the inspectors say he stole.  
 The total value of the goods taken by Florence is estimated at \$700, and consists of articles taken from the parcel post. In the collection is a large lot of silverware, most of it engraved; three watches; a diamond ring; an assortment of silks and linen goods, some made up into expensive garments, and others in bolts; a hand bag, and the like.  
 Inspectors say that Florence gave most of the women's clothes to his wife, who was said to be the best dressed woman in Albany's darktown society. Among the booty are several expensive evening dresses. Most of the goods will be returned to their owners.

A Trumpet Call to Georgia.

"The law-abiding people of Georgia, who constitute the great mass of its citizenship, will not be silent or indifferent when confronted by an issue like this. What we are dealing with is anarchy in its most dangerous form. If it continues no man's life will be safe. Today the mob claims one victim for one cause; tomorrow, unless this lawless spirit is curbed, a larger mob will claim a hundred lives on some other pretext. This spirit must be crushed with relentless determination. Therefore, we call upon the Governor and all officers of the land, to use all the power of the State to bring the guilty parties to justice."

There are courage and wisdom and patriotism behind these words from the resolutions adopted Thursday by the directors of the Atlanta Chamber of Commerce. They bespeak the thought and conscience of all Georgians who are devoted truly and intelligently to their Commonwealth. They ought to be read openly and supported earnestly by every commercial and civic body in the State. When the issue is drawn so clearly as now between government and anarchy, between the reign of law and the rule of mobs no organization that stands for the progress and well-being of Georgia can afford to be silent or passive.

This is not a matter to be settled by the sneers and abuse of the northern press or by the counsel of self-righteous critics in any corner of the Union. It is a matter to be settled by the moral sense and determination of the people of Georgia themselves. It is our shame, and our problem and, above all, our opportunity to vindicate our good name and put down unspokeable perils. If the spirit in which the Atlanta Chamber of Commerce has spoken is expressed by every chamber of commerce and every board of trade in the State and is put into practice by responsible authorities, Georgia will shine before the world in her true light and as her true self.

There was never a time when good citizenship had a more insistent and solemn call to duty. Here is a chance to render the State everlasting service. Whoever now speaks for law against lawlessness speaks for the profoundest interest of the individual and the community. Whoever now acts for law against lawlessness acts for the most precious and most vital things which our civilization has bequeathed us. If mob murder goes unrebuked and unpunished, if mob vengeance is allowed to batter down all bulwarks of justice, and mob madness to defy all principles of government, no man's property and no man's life will be safe. In justice to himself as well as to his State, every upright citizen of Georgia should face this issue squarely, and speak and act as wisdom and duty demand.

"A little fire is quickly trodden out,
Which, being suffered, rivers cannot quench."

The mob frenzy manifested this week in Georgia is alarming indeed, but it can be stamped out if the thoughtful people of the State and the responsible officers of the State determine now that it shall be stamped out. Otherwise, Heaven forbid the limits to which the murderous flames may sweep.

The Chamber of Commerce resolutions sound a trumpet note, when they declare:
"We call upon all true and brave Georgians to lift up their voices in denunciation of this foul crime and its perpetrators. Let every man show that he is on the side of law and order, giving no countenance to trucking demagogues who pander to the mob, and let every man who is a man stand ready to support and actively aid the officers of the law in stamping out the mob spirit wherever it is found."

To this patriotic call, every good citizen and every representative body in the State should respond. There should be a determined and organized effort to see that justice is done at this time in order that justice may be secure hereafter. The Governor should be sustained in his every purpose to redeem the State's integrity and to protect its well-being; and all other officials should be urged to exert themselves unsparingly to the same high end. Let us confront secretly organized lawlessness with publicly organized constancy, and lawlessness will be crushed.

Don't call him a spider, because he isn't. Spiders bite and have poison glands. This insect is perfectly harmless. Teeth Affect Morality.

The hygienic importance of keeping the teeth well cleaned is appreciated today by most people. Thanks largely to the "toothbrush campaign" carried on by school authorities, it is generally appreciated in the fact that tooth decay sometimes has a disastrous effect, not only on the body, but also on the mind and the morals.

Some thinking men, as has ever come to my knowledge of the influence of diseased teeth on morality, is the story of a Cleveland young man, for instance, who, while retaining whose singular case I am indebted to the late Dr. Henry S. Upson.

Brought up in a good home, this young man, as a boy, showed no traits out of the ordinary. Until about fifteen he behaved much like any average, virtuous lad.

At fifteen his mother was startled and dismayed by a sudden change in his character. He became mischievous, unruly, and given to roaming the streets.

Some neighbors began to complain, and he was accused of taking one person's bicycle to pieces, of stealing another's milk bottles, of overturning the neighbors' car.

Next he started in earnest in a criminal career, breaking into Y. M. C. A. lockers, pilfering from barns, and finally robbing a store. Arrested, but released for lack of evidence, he promptly committed another burglary.

This earned him a two-year term in the Ohio state reformatory. He was no sooner freed than he turned bad again, and this time was sent to the local prison.

There he remained until he was twenty-one, when his mother, in a last desperate effort to save her boy, took him to Dr. Upson to make a medical examination of him.

It was her idea, from a recent reading of medical literature, that possibly some abnormal physical condition might be the cause of his delinquency.

Visiting the prison, Dr. Upson was much impressed by the deplorable state of the young man's teeth. Several were impacted—that is, crowded against those of the old variety, and the new ones revealed abscesses at the roots of several others.

Given dental treatment a great improvement in his behavior became apparent. He lost his silliness and misanthropy, and at his mother's home sought work and kept at it steadily.

A year later the mother was able to write to Dr. Upson a letter of grateful assurance that her son was now a law-abiding citizen.

How account for this strange effect of dental disease of character? Simply by the fact that the young man's brain had been poisoned by the products of tooth decay.

Also his whole nervous system had been unduly taxed by the prolonged presence of the impacted teeth against the teeth adjacent to them.

The poisoning of the brain had weakened his powers of reason and judgment. The nervous strain had produced insanity in his mind, and he was a danger to himself and others.

Use the toothbrush vigorously therefore in the interest of morality as well as of physical health.

be worth five cents at a pound. Grain farmers and live stock raisers would at least have enough to eat, but cotton is the food for man or beast. The cotton farmers of Senator Smith's own state would suffer. Congress could not make a "bluff" about declaring an embargo and draw back if "the bluff was called" without making this great country the largest market in the world.

It would be madness to take chances on what would be the allies' reply to our embargo. From the beginning the unexpected has been happening in this war. We must maintain our rights and claim our just dues, but we cannot afford to throw away the millions of dollars of the cotton trade in the current fiscal year.

Senator Smith speaks of cargoes of foodstuffs as well as cotton that have been seized by the allies. He suggests to add that payment for them has been offered, though he does admit that the allies have made no advance damages for such seizures.

It is useless to disguise the fact that cotton planters are not an fortunately placed as grain farmers and stock raisers, but the outlook for the former is far more gloomy than that of the latter.

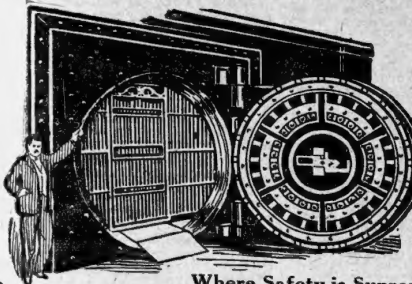

## BEAVERS' COURT FIGHT CANNOT LAST BUT YEAR

So Say Attorneys for Ex-Chief as Petition for Write Is Sanctioned

Judge John T. Pendleton, of the Fulton superior court, Friday morning sanctioned a writ of certiorari in the case of James L. Beavers against the board of police commissioners. The action of Judge Pendleton means that the trial of Beavers by the police board, resulting in his demotion to the rank of captain and causing his retirement from the force, will be reviewed by the superior court.

Unless the police board takes issue with the allegations of fact set forth in the Beavers petition for the writ, the case will be heard and decided by one of the judges of the Fulton superior court. If, however, the accuracy of the facts in the petition are questioned by the police board, then the issue thus made will be submitted to a jury for determination.

Attorneys for Beavers stated Friday morning that within year's time the case will be outside the case will have been adjudicated by the courts, even if it goes to the state supreme court. They expressed every confidence that Beavers would win.

If the courts sustain our contention, as we confidently believe they will, the proceeding which will result in sending the case back to the police board for retrial, explained Attorney Key.

"Mr. Beavers will be restored to his former position as chief of police, suspended, however it may be constituted at that time and whoever may change its personnel."

Although the civil service law regarding the police department provides that a decision of the police board shall be final, attorneys for Chief Beavers contend that the courts will ultimately take cognizance of his appeal.

They point to the 126 Ga. in the case of Tibbs vs. the City of Atlanta in which the supreme court held that a judgment of the board of police commissioners is subject to review writ of certiorari.

Accompanying the Beavers' petition, is the stenographic report of the evidence taken by the police commission in the trial of the former chief. This evidence covers the written pages, which cost Beavers \$300.

The petition itself covers ten typewritten pages in which the following are some of the chief allegations:

1. The judgment of the police board is contrary to law, contrary to evidence and against the greater weight of the evidence, and without evidence to support it.
2. The police board erred in overruling the demurrer and objection to the charges preferred against Beavers.
3. The board permitted Edwin F. Johnson, one of its members, and an ex-officio councilman, to employ counsel to represent the prosecution of the case, to examine witnesses, to argue demurrer, etc., over objections of other members of the board and over the objection of Beavers.
4. Edwin F. Johnson participated in the trial and in the findings of the verdict, being one of the commissioners who voted for removal of Beavers.
5. The board admitted evidence of alleged insubordination which occurred after the charges had been formally presented and after Beavers had been suspended as chief of police.
6. Chairman Fain ruled out of order a question seeking to show who employed Charles T. Hopkins, an attorney in the case.
7. The trial was stopped before defendant was ready, and while he was still in the act of introducing evidence in his defense.
8. After the trial had been concluded and the board had retired to make its judgment and verdict, the vote stood six for removal and six against it, and the defendant contends that this result prevented his removal from the position of chief.
9. The petition recites the facts surrounding the all-night session of the board, its adjournment the following morning, and its meeting again that afternoon.
10. The motion having been put to remove him as chief of police, and there not being a majority of the board in favor of that motion, any veto petition, and the board having adjourned to a subsequent time, the action of the board to remove him to his position because of the failure of the motion and because of the subsequent vote removing him was illegal and void.

"Be it resolved, That the Atlanta Clearing House association respectfully requests Governor Harris not to include the subject of prohibition in his call for the extraordinary session of the legislature.

Governor Harris expects to announce next week the date he has fixed for the legislature to convene in extra session and his decision as to the subjects to be included in his call.

### HARRIS TO URGE COURT TO PUNISH 'VINCENERS'

Governor to Confer With Judges, Solicitors and Sheriffs of Baldwin and Cobb

Governor Harris stated Friday that he will request the judges, solicitors and sheriffs of Baldwin and Cobb counties to call upon him in his office for the purpose of urging them to exert their utmost efforts to bring to justice the members of the mob who killed Leo M. Frank from the state prison farm at Milledgeville last Monday night. Harris carried him more than 100 miles in automobiles to a point near Marietta, Ga., where he was buried in Mount Carmel cemetery, Brooklyn.

"I will ask the judges to charge the grand juries especially on this subject, and will ask the solicitors to make every effort to ascertain the guilty parties, and will ask the sheriffs to cooperate fully with the solicitors and judges," said the governor.

The lynching of Frank was a blot upon the fair name of our state that can never be erased until the guilty men are punished to the limit of the law.

The governor explained that Baldwin and Cobb are the counties selected for the reason that Milledgeville, in Baldwin county, is where the removal of the convict from the state prison took place, and that the spot where Frank was hanged, in Cobb county, is the location of the taking of Frank's life by the mob.

The governor late Thursday afternoon issued a statement concerning the lynching of Frank and issued a reward of \$1000 for the apprehension of any three members of the mob, making the total reward \$3000. It was the governor's intention to offer five rewards of \$1000 each, making a total of \$5000, but on account of the order of rewards already offered he found that the total is \$7,500, and inasmuch as the total amount available for rewards is only \$1,000, the governor felt that \$1,000 was the limit he could offer in the Frank lynching.

**LANGUAGE OF REWARD.**  
The governor's reward proclamation deals with the lynching in the following language, it says:

Executive Department, Atlanta, Aug. 19, 1915.—Whereas, official information has been received at this department that the mob in Baldwin county, Ga., in this state, one Leo M. Frank, a prisoner, held in custody of the state, was recently taken from the hospital of the state penitentiary in Baldwin county, and found dead in the county of Cobb on the morning of August 15, 1915, having met his death at the hands of unknown parties; and, whereas, such conduct is an attack upon our civilization, besides being a grave violation of law, which the dignity of the state and the good name of the state require to be fully investigated and the offenders brought to punishment in accordance with the laws of this state; and, whereas, the secretary of state record and issue a proclamation offering a reward of \$1000 each for the first three persons convicted of said offenses, for their apprehension and delivery to the sheriff of Baldwin county, Georgia, with evidence sufficient to convict.

GOVERNOR'S STATEMENT.

Governor Harris' statement is in full as follows:

"In view of the great interest felt in all matters pertaining to the lynching of the prisoner Frank, I have thought it well to make a statement to the public, explaining as far as I am able the facts that led up to the transaction, and the situation that made it possible.

"Under the laws of Georgia, all alleged male convicts are to be kept and worked on the chaingangs of the different counties, or the public works of the state.

"There is a state farm at Milledgeville, primarily intended for the broken down convicts; those who are sickly and unable to do service on the road; for all those convicts, and for all boys not over 16 years of age.

"The prison commission may direct some convicts sent to the farm whose services can be utilized in the office, or do other work on the farm, but generally these convicts are kept upon the roads of the several counties, as long as they are able to perform the work required of them. Sometimes the trial judge sentences a prisoner to the chaingangs of the county chaingangs. This can be done by the presiding judge.

"There are some eight hundred prisoners on the state farm, counting the women, boys and other prisoners.

"When Mr. Frank's sentence was completed by Governor Harris, he was sent to the state farm for the purpose of being delivered to the prison commission at that point. He could have been sent by the commission to one of the county chaingangs of the state, or he could have been kept in the prison, in the discretion of the commission.

**ACTION NOT SAFE.**  
The excitement which attended his entrance into the prison was such that no disposition that would send him away from it seemed to be advisable. As after events have shown, there was really no gang in Georgia where he would have been secure. He was kept at work, therefore, in the prison as other prisoners, awaiting any other disposition that might be found advisable.

"The state penitentiary, as it is called, was never built with the idea of preventing an attack from the outside.

"Any determined body of men would be able to effect an entrance, if such an attempt was decided upon.

"There was no stockade around the prison; only a wire fence. It was found only at the time of the attack, and could have been easily broken at any point.

"The vast building was full of windows, both in the basement and main story. It was like a dormitory; one great sleeping apartment, the prisoners working out upon the farm in day and occupying the sleeping dormitory at night. The gate stood side by side in easy proximity. This method of taking care of the prisoners at night has been found to be the least in the south.
