TENSION IS RELAXED BY GERMAN'S ACTION

Germany to Send Formal Note of Disavowal and Offering Reparation for American Lives Lost—Outcome is Hailed as Great Victory for American Diplomacy.

Washington, September 1.—Strained relations between the United States and Germany over the submarine warfare apparently passed into history today after Count von Bernstorff, the German ambassador, informed Secretary Lansing in writing that prior to the sinking of the Arabic his government had decided that it summarily would sink no more liners without warning.

Oral assurances to this effect had been given by the ambassador last week. But it was not until Count von Bernstorff, after a call at the state department today, returned to the embassy and sent a letter to Secretary Lansing, that the German government's instructions from Berlin concerning an answer to be made to the last American note on the sinking of the Lusitania that officials frankly admitted their gratification over the changed position of the imperial government.

Secretary Lansing said in a formal statement that the letter "appears to be a recognition of the fundamental principle for which we have contended." He immediately sent the communication to the white house and discussed it in certain terms with the cabinet, who included Chief Justice White, Secretary McAdoo and Senator Truman, of South Carolina. Everywhere in administration circles there was a visible relaxation of the tension which had existed ever since the Lusitania tragedy, though lessened by earlier assurances.

EXCHANGE RATES
QUESTIONS

Ever Reached in United States—Entire Market in Convulsions — Bankers, However, Remain Calm as Speedy Relief Is Predicted.

New York, September 1.—Foreign exchange rates, led by the English pound sterling, played fast and loose today in the checkered board moves over the lowest plane of values ever reached in this country.

From extreme depression of \$4.80 on the opening, sterling faltered to \$4.55 in the late afternoon and fell back at the day's end to \$4.61. France dropped at a single stroke from \$23 to \$22, reaching their lowest value. Lira hovered around 8.1, approximately 15 per cent below their normal value, remaining there because they virtually amounted to nothing in the day's dealings.

The entire market was in convulsions throughout the day, but the tendency toward hysteria lessened toward the close.

Bankers were inclined to calm, rather than hysteria. One foreign exchange expert asserted tonight that he doubted if 10,000 pounds sterling had been bought in this market today.

Bankers reported in sight. For reasons not seen on the surface, optimism was more apparent tonight than analysis of the situation seemed to warrant.

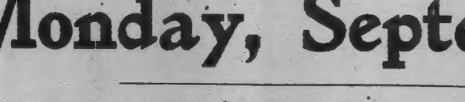

A YEAR AGO AND—NOW.

Looking back just one year, the south has every reason to congratulate itself upon the revolution which has taken place in conditions surrounding the market for cotton and, logically, therefore, as to those relating to business generally.

One year ago brought the end of the first month of the European war. The stock and cotton exchanges were closed, the financial world had been stamped and business generally was in chaos.

In the beginning of this financial cataclysm the south was floundering, knowing not where to turn. The cotton states were pictured as standing upon the curbstone with beggary, destitution and desolation.

Business in every line was affected; buying was cut to a minimum; traveling men remained at home; mills, shops and factories of all sorts curtailed their output and reduced their forces; railroads laid off their hands by the thousand, and the south throughout its length and breadth was reduced to a basis of economy such as it had scarcely known before even in panic periods.

What really happened was, as gradual readjustment came about, that we slipped approximately as much cotton as during the year before, and with every business settled upon the basis of rock bottom economy, conditions began slowly but substantially to improve.

Providence came to the rescue as it often does, assisting even well intentioned crop curtailment, so that today we have a crop of something like 4,000,000 bales less than that of 1914. This crop difference practically equalizes the surplus carried over from last year, and today our cotton is selling at above 9 cents.

coming was delayed by a year; it is before us now. Conditions are ripe for an active and prosperous fall and winter as business could wish or demand. It will be ours to the full extent that we make it so. We should get ready for it and help build, our success, already full of promise, will be the greater in fulfillment as we work to back it up.

NO DOUBT REASSURES.

There is gratifying reassurance in the announcement of Superintendent Landrum, of the city's schools, that there will be no double sessions, even temporarily, upon the opening of the schools this month.

Where additional rooms, planned to meet and avert this situation, are not finally completed, the classes will be delayed for a few days, rather than put pupils, parents and teachers to the annoying inconvenience so well remembered by those who had to contend with double sessions during the last scholastic year.

The Constitution, the Atlanta School Improvement association and other organizations made their fight last winter and spring, largely to rid the school system and its patrons of this nuisance which was one of the chief evidences of school inefficiency.

That fight was won in June, when the city council found and appropriated \$45,000 to rehabilitate the system to the point where it could meet the demand upon it. Assurance, the most positive, was then given that double sessions would be banished for all time.

Superintendent Landrum's announcement is merely reassuring. The Constitution pointed out in June that the time was short, and that conditions were to be remedied in time for the opening of the schools upon the usual date in September, quick work would be necessary.

The time has been barely sufficient to complete the necessary work. In a few instances new schoolrooms will scarcely be ready for their classes on Monday, September 13. It will, however, mean a difference of only a few days at most, and it is better to wait than to inaugurate the policy of going back to the obnoxious plan of double sessions.

Atlanta hopes, trusts and believes this double-session business has been abolished from her schools for all time. School patrons will be reminded of it by even the most transitory restoration.

Women Should Conduct a State Beauty Campaign

By Irma Dooly. "Why not start a beauty campaign for Georgia women?" is the message a Georgia woman brings back from California.

She had just returned from a visit to the California people in cultivating their beauty, and she has returned with every plot of ground coming under the observation of the human eye.

"I was charmed with the beauty of California," she said, "and marveling at the cultivation of it. It was more impressive with the women and the people in their resources; their continued and active development of them, and the patriotic pride which marked every phase of life in the southern state."

"It would appear that everybody had entered into a 'beauty' campaign, for there was not a tree uncared for, a plant unwatered, nor a flower not encouraged to put on its best bloom. There were no scraps of paper, no dirt in any line anywhere, and the cleaning up in California was the beautifullest going on day and night."

"Out in the country the same practical and aesthetic work goes on. The rural people, with their 'good' and 'great' raising, and their agricultural thrift, have the same appreciation of the beauties of their land. They planted or transplanted in cared for and cultivated in its growth with results that make California a more beautiful and more progressive state than any other."

"There are three months of rain out there; the remainder of the time they must look out for their crops. They have their trees from the acres of rich vegetation to the finest plot growing under the window in a raised garden. The cultivation in the most perfect in the world."

"The rural people present the picture of little parks in which people are living with everything as beautiful as if their only aim was to make their homes beautiful, and yet everybody works and everybody has time for their beauties, conserve and cultivate them."

"All the western cities and the towns where civilization has touched, produced the idea of cleanliness and order. I saw a disorderly village, neglected home, and a beautiful city. 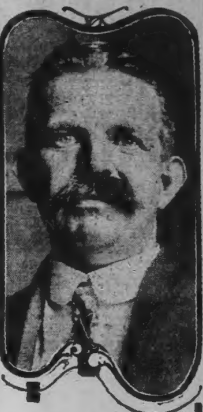
