THE GERMAN ARMY

Von Hindenburg's Army Well Astride Drinsk-Vilna Road, and Both Drinsk and Vilna Are Menaced.

Another Advance Made by the German Army.

MUNITIONS OF WAR MAY BE EXCLUDED

From the Exports to Be Paid For by Proceeds of American Loan to Allies. Pro-German Banks Balk at Munitions.

New York, September 17.—The Anglo-French financial commissioners seeking to establish a mammoth credit loan here, and American financiers who expect to supply the money, were reported to be at odds tonight over the question of including war munitions among exports to be paid for by proceeds of the loan.

The bankers and the bankers have agreed on several details, but on this major question, it was said, their views are diametrically opposed. There also is an apparent split on the question in the ranks of the American financiers. It was said tonight.

The commission's attitude is said to be that the big credit, whether a billion dollars or less, should provide funds for all exports and that munitions should be included. Some American bankers think so, too; but a great many are said to be of the opinion that the loans should cover only such exports as wheat, cotton and manufactured products, and that another method must be found to pay for munitions, even if it involves shipment of huge stocks of gold.

The situation has not reached a deadlock, or anything approaching it, but the line of demarcation is clear and well defined.

GERMAN ARABIC DIPLOMACY

Berlin Believes That Differences Will Be Discussed in Informal Conversations. Agreement Is Expected.

Berlin, September 17.—(Via London.) James W. Gerard, the American ambassador, called on Dr. Gottlieb von Jagow, the foreign minister today, presumably in connection with the situation that grew out of the sinking of the Lusitania.

Nothing can be learned here to confirm a Washington dispatch saying that the intention is upon conversations between the two countries on the submarine situation, but officials generally assume that the meeting is correct and express the belief that difficulties between the United States and Germany would be on a better way toward settlement by such a method.

Differences in viewpoints which are only stiffened when laid down in formal notes, can, officials believe, be more easily adjusted in informal conversation, and all the more so, they say, because the fundamental differences of policy have largely disappeared under the new instructions regarding attacks on passenger steamships.

The United States and Germany, it is declared, appear to be now in substantial agreement on the principle involved, and it is now largely a question of adjusting cases like the Arabic in conformity with that principle.

Germany, it is believed here, will be ready to consider testimony bearing on the point of how far the captain of the submarine was justified in his belief that the Arabic was not an attacking ship, and that in conversations she will have the opportunity to satisfy the American government that her policy and practice under present conditions will harmonize in the future.

Under the heading, "Freedom of the Seas," the Roosevelt Zeitung takes occasion to state for her attitude toward submarine warfare. It is a remarkable coincidence, this newspaper says, that two nations among which the same goal should become involved in such serious dispute should be the same goal.

Placards Against Loans. Opponents of the loan exact their campaign into Wall street today and throughout the city. Placards in flaming placards in front of the office of the Morgan bank.

BULGARIA'S HELP POST TO THE ALLIES

Turco-Bulgar Agreement Means That Allies Have Failed in Part of Diplomatic Contest to Swing the Balkans.

Bucharest, Rumania, September 17.—The allies know that in no case may they count on Bulgaria's help on the Balkan peninsula, says the semi-official independence Romaine in an article dealing with the Turco-Bulgar agreement. They have lost that part of their diplomatic contest in the Balkans which remains to be won here, the other part will come out.

"King Ferdinand will leave tomorrow for a week's vacation on the Danube. This fact completely disposes of reports concerning the activities of Rumanian troops on the frontier, which in reality are nothing more than the annual maneuvers."

Vienna, September 17.—(Via Berlin and London.) The surrender by Turkey to Bulgaria of the territory from the Dedoplistskan railroads to the Danube, the thirteenth anniversary of the annexation by that nation of eastern Rumania. A royal decree announcing the acquisition of territory will be read all over the country.

Turkish Deal Offered. Paris, September 17.—A dispatch of the Balkan agency says that the leaders of all the opposition parties in Bulgaria have held a meeting, at which it was decided to publish an appeal to the country expressing the international political situation as affecting that nation. The appeal will be made on the ground that under present circumstances the attitude taken by the government is perilous.

The Bulgarian government's decision to make terms with Turkey has met with considerable opposition. Advice from Bucharest recently reported a majority of Bulgarian statesmen as favoring a compromise with the quadruple entente, Serbia and Greece.

German Promise to Bulgaria. (Via Paris.) The Stampa says it has learned from a diplomatic source that German officials had extensive promises to Bulgaria to obtain that nation's benevolent neutrality in such serious dispute which were made to King Ferdinand of Bulgaria by the grand duke of Baden-Baden on behalf of Emperor William, and that among them was the stipulation that the territory now held by the various Balkan nations and European Turkey.

GREECE AND BULGARIA AT STALEMATE. Athens, Greece, September 17.—(Via Berlin and London.)—There are indications that the relations between Greece and Bulgaria are improving. In the most influential circles the conviction is said now to have been reached that neutrality must be the only policy.

The utterances of Premier Radoilov of Bulgaria, which have been the hope for more cordial relations with Greece, have made a deep impression, as has also the declaration that the future of the Balkans depends upon an understanding between these two nations.

GERMAN ARABIC DIPLOMACY

Berlin Believes That Differences Will Be Discussed in Informal Conversations. Agreement Is Expected.

Berlin, September 17.—(Via London.) James W. Gerard, the American ambassador, called on Dr. Gottlieb von Jagow, the foreign minister today, presumably in connection with the situation that grew out of the sinking of the Lusitania.

Nothing can be learned here to confirm a Washington dispatch saying that the intention is upon conversations between the two countries on the submarine situation, but officials generally assume that the meeting is correct and express the belief that difficulties between the United States and Germany would be on a better way toward settlement by such a method.

Differences in viewpoints which are only stiffened when laid down in formal notes, can, officials believe, be more easily adjusted in informal conversation, and all the more so, they say, because the fundamental differences of policy have largely disappeared under the new instructions regarding attacks on passenger steamships.

The United States and Germany, it is declared, appear to be now in substantial agreement on the principle involved, and it is now largely a question of adjusting cases like the Arabic in conformity with that principle.

Germany, it is believed here, will be ready to consider testimony bearing on the point of how far the captain of the submarine was justified in his belief that the Arabic was not an attacking ship, and that in conversations she will have the opportunity to satisfy the American government that her policy and practice under present conditions will harmonize in the future.

Under the heading, "Freedom of the Seas," the Roosevelt Zeitung takes occasion to state for her attitude toward submarine warfare. It is a remarkable coincidence, this newspaper says, that two nations among which the same goal should become involved in such serious dispute should be the same goal.

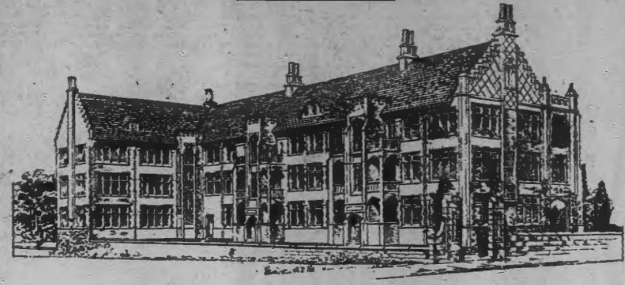
