



MISS BOYD EXPLAINS HER RECENT RESIGNATION

Says She Only Agreed to Work for Present Salary Certain Time

Editor The Journal: Mr. W. M. Everett, president of the library board, has stated so fully the reasons for my resignation as librarian that it seems useless to attempt further explanation, but so many people have questioned the advisability of the requested raise in salary at this time of financial trouble that I feel that I must go into the situation in detail, and try to make quite clear the fact that the library board is not now asking for an additional penny from the city and not asking for a cent of funds from one appropriation to another, but simply for permission to use for the requested increase money which the city has already appropriated for salaries last January and which has not been used because of our inability to secure training librarians at a minute's notice in several cases.

Since I have been librarian I have secured raises in salary for most of the junior members of the staff, and have secured the beginning salary for \$10 to \$50 per month. Then, in January, 1913, I asked for a raise in my own salary. It was refused by the board, although recommended by the library board. I stated that I could not hold the position longer than one year unless the present salary from the city was increased. City Recorder Tenders Resignation as Prelude to Taking Appellate Court Seat

"I believe that today Atlanta is the most law-abiding city in the union," is the declaration of Judge Broyles, made in his formal resignation of the office of city recorder, tendered Saturday to the mayor and council of Atlanta. Judge Broyles quits the recorder's bench to take his seat on the state court of appeals, to which he was nominated by the voters of the state in the recent primary. He will assume this position as soon as the returns of the election November 3, are certified by the secretary of state.

It is thought quite certain that Judge Broyles will be called to the November election, to fill out Judge Broyles' unexpired term, which does not end until the first Monday in July of next year.
