BATTLEFIELD COVERED WITH DEAD AND DYING SOLDIERS, SAWS BERLIN

Losses of Both Germans and the Allies in Long and Desperate Battle Described as Fearful

FALL OF LEMBERG NOW IS EXPECTED ANY HOUR

Austro-German Armies Are Now Shelling Main Russian Positions Few Miles From Galacian Capital

(By Associated Press.) WASHINGTON, June 22.—Wireless dispatches from Berlin represent the battle which has been in progress for some time in the vicinity of Arras, France, according to the progress of the conflict of the war, which may decide the fate of France. Losses of both the German and the Russian forces are described as fearful, and one eight-mile stretch of field, from Arras toward the Belgian border, is said to have covered with corpses.

The official French and German statements today give few details of the battle. The Paris announcement concedes that the Russian captured a section of a trench at one point, but asserts they were repulsed elsewhere. The Berlin statement mentions no fighting.

In Alsace there was heavy fighting along the valley of the Rhex. The French assert their lines were pushed further northward. The Berlin communication says the Russian positions were transferred to the eastern bank of the river.

An unofficial message from Berlin says the Russians have been defeated all along the front in the case of Lemberg, Galicia, and now are fighting for time to save their guns and other war material. It says that the Russian and Austrian and German are ten miles from Lemberg.

It is believed that the French coast, was bombarded again yesterday by a long German and Austrian air force. The report of a Saopart of Libau is now being strongly fortified.

LONDON, June 22.—Nothing but a sudden and unexpected blow by Grand Duke Nicholas, commander-in-chief, can now save Lemberg, the capital of Galicia, in the hands of the Russians for the moment. WILSON IS STUDYING NEW SEAMAN'S LAW

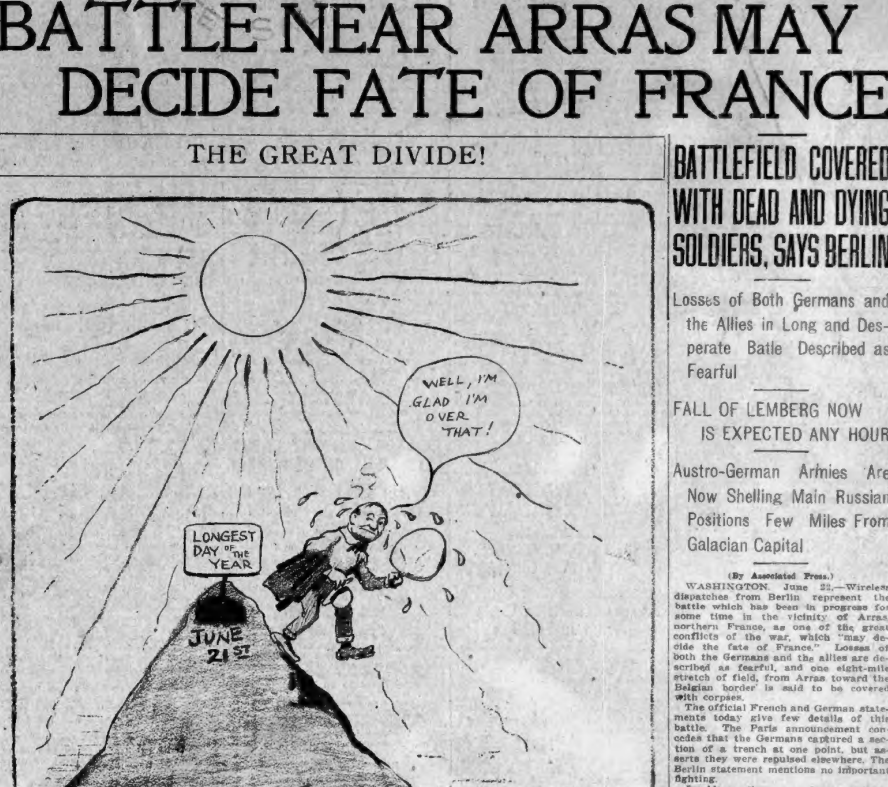

The board of education recently voted to adopt the merit system of salaries for the teachers; to require them to be subject to the orders of the board for eleven months each year instead of nine months; and to fix an annual scale of salaries. This action, however, was subject to ratification by council. Monday afternoon council adopted an ordinance by Alderman Albert Thomson, repealing the ordinance relative to teachers' salaries and conferring the power on the board of education to make its own regulations, which will be those recently adopted.

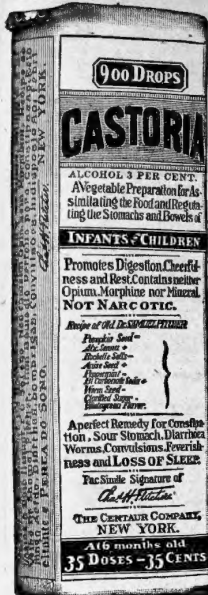

FATHER BELIEVES HIS SON WAS KIDNAPED

Crawford Sewell, 14, of College Park, Disappeared Monday

Circumstances surrounding the disappearance of his son Monday afternoon, have led Dr. J. A. Sewell, a prominent physician of College Park, to fear that the boy was kidnaped and is traveling through the country with an itinerant salesman of pictures. The boy, Crawford Sewell, fourteen years old, has not been seen since late Monday afternoon, when, it is said, he was lured into a buggy by a strange man while returning with three playfellows from a swimming hole near College Park. The stranger made his appearance in College Park Monday afternoon, where, according to citizens, he would go from house to house on the pretense of selling pictures, but with a series of questions which indicated other motives. At the Sewell home he asked Mrs. Sewell if she had a little boy, a question he also put at other houses. When she replied in the affirmative, he asked her if Dr. Sewell owned his home and what it was worth. These questions, it was learned, he had also asked at other residences. He then told Mrs. Sewell he would like to see her son, that he needed a boy to work for him. When she pointed out the general direction in which Crawford had been taken, the stranger drove that way with his buggy. Three friends of Crawford's reached the Sewell house shortly afterward and told Mrs. Sewell their man had met Mrs. Crawford and Crawford to get into the buggy, saying: "Your mother is going to let you work for me a while." Crawford got into the buggy and that was the last seen of him, so far as known. His mother at once began an inquiry. She telephoned the livery stable and found that the stranger had been there. The liveryman said the stranger telephoned him Monday afternoon that he would be back until Tuesday afternoon. Crawford's parents are considerably worried over his whereabouts and will appreciate any aid the public can give in locating him. He is five feet tall, weighing between eighty and ninety pounds, slender, black-eyed, light-haired. He wore blue overalls, a blue shirt, wide-brimmed straw hat and was barefooted.

CANDIDATES FOR SPEAKER CLAIM VOTES TO WIN

W. H. Burwell and J. E. Shepard Confident of Election Wednesday

Chief interest Tuesday in the opening of the general assembly Wednesday morning at 10 o'clock centered about the election of a speaker, the election of a speaker pro tem, and the movement on the part of some members of the house to take away from the speaker the appointment of the rules committee and make the members of this committee elective by the house.

At the headquarters of each of the rival candidates for speaker—Representative W. H. Burwell, of Hancock county, and Representative J. E. Shepard, of Sumter county—confident claims concerning the outcome of Wednesday's election were made.

The Burwell headquarters claimed 160 votes for their candidate, and declared that of these votes had been unconditionally pledged to Mr. Burwell in writing. These pledges were said to be open for the inspection of any person interested.

Those in charge of Mr. Shepard's headquarters claimed their candidate was certain to be elected, although they conceded the race would be a close one. They said a big majority of the members of the house were in opposition to that these were coming to Mr. Shepard constantly increasing numbers.

The following statement was issued Tuesday from Mr. Shepard's headquarters: "It is true if Mr. Shepard had not entered the speakership race Mr. Burwell might have been elected. The course of Mr. Shepard's campaign during the completion of affairs. Quite a few of the representatives who intended at one time to vote for Mr. Burwell will now vote for Mr. Shepard."

Mr. Shepard's position on letting the members elect the rules committee and thus control the house is popular. Mr. Shepard has all along favored this and that fact is bringing strength to his position.

SPEAKER PRO TEM. The race for speaker pro tem is between Representative Robert Lebour, of Crawford county, and Representative C. Stewart Coffee county, Representative D. B. Elliott, of Campbell county, who has been frequently mentioned as a candidate for this office, announced Monday that while he was gratified to his friends for their promise of support he would not be in the race because his personal and business affairs would not permit him to give the necessary time and attention to the office in the event of his election. Mr. Elliott's friends are supporting Mr. Lebour.

It is difficult to predict the outcome of the movement to revise the rules of the house by making the rules committee elective by the house. This is one of the principal planks in the platform of Representative Shepard, one of the candidates for speaker.

Mr. Burwell's friends are vigorously opposing the movement on the ground that it is nothing more nor less than an attack on the political honesty and integrity of Mr. Burwell and grows out of the fact that some members of the rules committee appointed at the last session of the legislature were not satisfactory to the leaders of the movement.

It is pointed out by Mr. Burwell's friends that the house always has it within its power to control the reports of the rules committee as the adoption of this committee's reports require a three-fourths vote of the house membership, and they further contend that the

COUNCIL VOTES LICENSES TO 152 BEER SALOONS

Action on Renewal of Club and Pool Room Permits is Postponed

After listening for half an hour to the protest of the Men and Religion Forward movement, the general council on Monday afternoon, by a majority of 24 to 4, voted to again license the 152 beer saloons in the city. Action upon the applications for renewal of permits of nineteen locker clubs was postponed for the reason that some councilmen are planning a fight on some of the clubs.

Action upon the applications for pool room permits was also deferred pending a report by the police committee on the applications of pool rooms, which are not separated from the beer saloons. During the meeting an ordinance was introduced by Councilman J. C. White to separate pool rooms and beer saloons, and council probably will pass on this measure before it takes up the applications again.

Council went into a committee of the whole to listen for half an hour to Marion M. Jackson who voiced the protest of the Men and Religion movement and of the citizens present at a mass meeting at the Grand theater last Sunday during the licensing of the clubs and saloons.

During his address Mr. Jackson said: "We wish you, the constituted authority, to take action; we are trying to avoid going into the courts with injunctions, although we could close them up immediately that way."

The following councilmen voted against licensing the beer saloons: J. L. McCord, J. C. White, C. W. Smith and A. T. Peacock.

WARE COUNTY MEMBERS WANT NEW LEGISLATION

(Special Dispatch to The Journal.) WATCHDOG, Ga., June 22.—Ware county's representatives have come to Atlanta with a batch of bills that are sure to attract more or less notice. DORSEY GIVES HIS VIEWS ON FRANK COMMUTATION

Solicitor Who Prosecuted Case Makes Statement on Action of Governor

Solicitor Hugh M. Dorsey, who prosecuted Leo M. Frank, has given out the following comment on Governor Slaton's action in commuting Frank's sentence to life imprisonment.

The action of Governor Slaton nullifying the judgment of the state and federal courts and overruling the recommendation of the state board of pardons was as surprising to me as it was unprecedented.

No defendant within my recollection has had the benefit of more appeals to the judicial process than Leo Frank. His guilt was conclusively established beyond a reasonable doubt to the satisfaction of an impartial jury of twelve reputable Georgians and their verdict was approved by the trial judge and affirmed by the supreme court of Georgia.

With the unbroken record of all available courts declaring Frank guilty of the heinous crime with which he was charged, the influential friends of Frank appealed to the state board of pardons elected by the people to pass on applications for pardons and commutations to be considered by the chief executive of the state, and the pardon board sustained the recommendation of the courts of justice and declined to recommend the application for a commutation.

I did not appear before the pardon board because I felt confident that with the evidence and the court records before them there would be no interference with the course of justice. When their decision refusing to recommend commutation was transmitted, I felt it to be my duty to plead for the enforcement of the law and the active because I knew the influence of the courts and of the pardon board.

I know that the senior member of Governor Slaton's firm, Thomas Slaton & Phillips, was the leading counsel for Frank, not only throughout his trial, but in prosecuting the original and extraordinary motion for new trial, and I knew it would be difficult for the governor to escape the subconscious effect of his environment.

The constitution of Georgia commands the impartial and complete administration of our laws, and imposes the command upon the solicitor general of each circuit, as well as upon the governor of the state.

My feeling that the governor was disqualified, at least to an extent, by his environment and affiliations, from viewing the records in this case impartially, prompted me to appear before him in person to urge the enforcement of the law.

Not one of the grand jurors, who found the true bill against Frank and not one of the jurors who convicted him in the trial for forgery, which was granted over the protest of the prosecuting attorneys and over the adverse recommendation of the state board of pardons.

I cannot find in the record of the Frank case, or in the governor's lengthy statement of attempted justification, one reason why the governor should have departed from his declared policy and interfere with the judgments of the courts in this case.

ADVERTISING CENSORSHIP DISCUSSED BY WILEY

Effect on Cash Drawer Topic of Address Before Ad Men's Convention

(By Associated Press.)
CHICAGO, June 22.—The Effect of Advertising Censorship on the Cash Drawer, was considered in remarks by Louis Wiley, business manager of the New York Times, at the Associated Advertising Clubs of the world. Mr. Wiley stated that he did not like the tone of the title assigned to him. "To keep advertising columns clean is not only the duty of the self-respecting newspaper publisher, it is to his advantage," he said.

"There can be no dispute as to the impolicy of printing a fraudulent advertisement. In addition, it is a poor way to build up business. There is no stability about that kind of advertising. Legitimate advertising helps to build up a newspaper. Fraudulent advertising helps to pull it down.

"There are many newspapers on a profitable basis which carry objectionable and fraudulent advertising. I know, however, of a number of newspapers now on the rocks which were once prosperous. I attribute their undoing to their lack of self-respect, lack of regard for their own reputations, and their heedlessness in printing unreliable news and advertisements. An honest self-respecting newspaper has the most enduring success.

"The sincerity of the newspaper which proclaims its devotion to the public welfare in its editorial columns and its advertising columns to quacks and frauds is open to question. There is no doubt whatever that the newspaper which in its advertising values an advertising medium is the one which declines fraudulent advertisements.

"The recently enacted New York state law against fraudulent advertisements is a wholesome thing and will have a highly beneficial effect. Equally desirable is the law passed by the New York legislature last year prohibiting the inclusion of advertising circulars in copies of newspapers.

"There can be little doubt that every man, newspaper or not, who gives rogues the opportunity of realizing their nefarious schemes is participating in the crime. It is the responsibility of fraud is accessory to a criminal offense. It has been said that if there were no rogues had no means of reaching the gullible part of the public their occupation would be gone.

"Newspapers as well as individuals are judged by the company they keep, and a newspaper which keeps its columns absolutely clean is the publication sought by the man who has a worthy product to sell. Such a newspaper does more than lend its circulation to an advertisement. It puts upon the goods the seal of the indefinable stamp of honesty. It has ready plowed the field he wants to sow.

"There are few editors who will allow a false dispatch or report in their journals. Why should a distinction be drawn with business news which affects the purses of their readers?"

"The censorship of advertising can be epitomized by a paradox. If it is loosened, the publisher will choose to do it on his own greed—if it is tightened and the newspaper has the favor of the public, the cash drawer will expand with honestly earned receipts."

WESTERN RATE ADVANCE ARGUED AT WASHINGTON

WASHINGTON, June 22.—Oral arguments were begun today before the interstate commerce commission in the western rate advance case, involving about 100 railroad operating west of the Mississippi river and east of Denver and New Mexico.

"The roads have proposed increases in freight rates on grain, live stock, packing house products, coal, vegetables and many other commodities. In hearings representatives of the roads have stated their revenue under the proposed rates would be increased about \$10,000,000 annually. Representatives of state railroad commissions have contended the increase would amount to \$10,000,000. It is expected that the arguments will continue for at least a week and that the decision probably will not be handed down until fall.

BERLIN TAGES ZEITUNG IS SUSPENDED BY OFFICIALS

Published an Article Saying International Law Must Be Disregarded

(By Associated Press.)
BERLIN, June 22.—(Via London.)—The authorities today suspended indefinitely the Berlin Tageszeitung because it published recently an article by Count Ravello von German-American relations which declared international law must be disregarded in submarine warfare.

"The suspension is regarded here as indicating the government is weary of seeing its relations with America made more strained by journalistic utterances of such a nature as Count von Ravello's. The article in question followed the well known line of that writer, who declared international laws were made before submarines were invented, and continued:

"And one can as little employ these rules in an objective common sense way as, for instance, one could bring the attitude of the office of an incompetent statesman into helpful relation to the well being of the whole people."

"The government's prompt action in suspending the Tageszeitung is but one of many indications that responsible statesmen are eagerly desirous of finding a common ground for an understanding with the United States.

"The Nord Deutsche Allgemeine Zeitung today publishes the following:

**OKLA. SUFFRAGE DECISION
CREATES INTEREST IN GA.**

**Possibility of Effect on Other
Southern States Attracts
Attention**

The decision of the United States supreme court in Washington Monday, June 21, in upholding the so-called grandfather clause of the Oklahoma state constitution, has created a great deal of interest in Georgia.

The unconstitutional provision of Oklahoma of the right of suffrage, but preserves the right to white citizens. In this general purpose it is similar to the franchise laws of other southern states.

Chief Justice Taft, himself a native of Louisiana, wrote the opinion of the supreme court in which the other members of the bench concurred.

Local interest in the decision is centered in speculation as to whether the Georgia disfranchisement law will be seriously impaired. Until constitutional lawyers and others familiar with the details of the Georgia law have been fully acquainted with the details and technicalities of the supreme court's decision there will be heard a statement as to its possible effect on the Georgia law.

It is known in Georgia, however, as it was well understood in Washington, that the Oklahoma provision differs in many radical particulars from the disfranchisement laws in some other southern states. From the disfranchisement laws in some other southern states, the Oklahoma law contains no grandfather clause, but does seek to preserve the right of suffrage to persons descended from ancestors who fought in the army or navy of the United States or the Confederate states, thus conferring suffrage in recognition of patriotic service, and not because of race, color or previous condition of servitude.

**Disfranchisement Law

Council Also Bans Sale of
Fresh Meat and Unwrapped
Ice Cream on Streets

The sale of fresh meats from wagons on the streets; the sale of unwrapped ice cream or ice cream cones on the streets; the operation of museums of anatomy and the profession of fortune telling, were all barred from Atlanta by ordinances adopted by the city council Monday afternoon.

The ordinances become effective immediately. They were approved by the tax committee, which also proposed in an ordinance to prohibit the sale of fireworks. This, however, was not adopted by the council.

Council voted to defer action on the report of the tax committee recommending a revision of the entire tax ordinance and an increase in the cost of many business licenses by 25 per cent. The tax ordinance will be considered at a special meeting of the council next Monday afternoon.

Anti-Liquor Convention Delegates Told of Plans for Legislative Fight

Three bills aimed at absolute prohibition, already drawn up except for the final touches, will be introduced for passage in the Georgia legislature this summer, said G. W. Eichelberger, president of the Anti-Liquor league, in addressing the anti-liquor convention of delegates from all over Georgia who met in the Baptist tabernacle on Luckie street Monday morning.

These three bills, said Mr. Eichelberger, are all ready for the legislature, and will be put on them Tuesday afternoon at the tabernacle convention by a committee on resolutions, of which Judge W. R. Hammond has been appointed chairman.

Those attending the convention were unanimous in their support of the bills, and many named legislators who, they said, would vote and fight for the measure.

Mr. T. E. Patterson, of Griffin, president of the Georgia Women's Christian Temperance union, presided at the gathering and promised the support of that organization, which, she said, was the largest of any kind in the state from center to circumference. She said the W. C. T. U. could reach ten thousand telegrams to the Georgia legislature urging the support of the three bills, and cited as an instance of such telegraphic expression of W. C. T. U. opinion made before the legislature last summer.

Dr. Jacob L. White, pastor of the tabernacle, called the convention to order Monday afternoon at 10 o'clock. J. Z. Foster, of Marietta, chairman of the morning session, which ended at 11:30 o'clock after an address by Dr. R. R. King.

The afternoon session, beginning at 2 o'clock, is in charge of W. B. Withers, chairman, Ex-Chief Justice Sam D. Wesley, of Alabama, will be the afternoon speaker.

Hooper Alexander will preside at the night session, with Congressman E. W. Clegg, of Marietta, as principal speaker. Judge Wesley and Mr. Webb were introduced to the convention at the morning session.

(Continued from Page One)

Standing room either inside or out when it drew up in front of the governor's home. Shortly after the street car unloaded its throng several companies of militia arrived in automobiles and took charge of the situation. Fifteen minutes after their arrival automobiles had begun to return to the city, and all who could do so were catching street cars.

At 10:30 a. m. the city police were left in undisputed control of the whole territory in the vicinity of the governor's home.

Tuesday morning the militia and the county police were still on the job, but the citizens had apparently satisfied their curiosity and returned to their daily pursuits.

GATHERINGS ELSEWHERE.

In several other Georgia towns there was more or less animated discussion of the Frank case Monday. At several points, notably Marietta, Newnan, Ringgold and West Point, there were gatherings and demonstrations, manifesting a protest on the part of those participating against Governor Slaton's action. But reports from all over the state Tuesday indicated that excitement had subsided and that the people were settling down to business. Those who approved the governor's action and those who disapproved seem equally tired of needless discussion and began devoting their minds and energies to other things.

MANY TELEGRAMS RECEIVED.

While those who disapprove of Governor Slaton's action have been making their attitude known by demonstrations, those who feel that the governor has acted in the interest of the state have failed to manifest their approval of his course by messages of congratulation. Since the announcement of the gubernatorial commutation Monday morning, an enormous number of congratulatory telegrams from people in all walks of life and from all parts of Georgia, and the union has poured into the governor's office.

In addition to expressions of approval by telegram a great many people called on the governor at his office in the city Tuesday and personally congratulated him.

Milledgeville Quiet Despite All Rumors

MILLEDGEVILLE, Ga., June 22.—Despite the rumors that Milledgeville was quiet last night and though every precaution was taken to provide for any emergency, little apprehension was felt at any uprising concerning the Frank situation.

Dr. J. H. Bradford is slated to replace Dr. G. L. Loden as head of the city tuberculosis sanitarium at Battle Hill, a position given temporarily to Dr. Loden several weeks ago, when Dr. Louis Hollander was discharged.

The fact that Dr. Loden, who was formerly assistant superintendent, is about to lose out, aroused the ire of Mayor Woodward Tuesday, and caused him to remark to the committee in charge, "Well, you might as well abolish this institution if you are going to play politics with it."

The sanitarium committee is composed of Dr. W. L. Gilbert, of the county board, Alderman Edges, Dunlap, Dr. J. P. Kennedy and Claude Smith, of the city health department, and the mayor.

During the course of a committee meeting Dr. Gilbert moved to go into an election of superintendent. Mayor Woodward objected, saying that he understood that Dr. Loden, who had been given the place temporarily, was proving a satisfactory official.

Dr. Gilbert and Alderman Dunlap openly stated they were for Dr. Bradford. Drs. Kennedy and Smith, who held their own positions through election by the board of health, of which the election of a superintendent was the second ward, remained silent during the discussion, but it is said they also will vote for Bradford.

Dr. Gilbert and Alderman Dunlap both vigorously denied the mayor's charge of politics.

Alderman Dunlap stated he simply did not consider Dr. Loden a young man to be a person of sufficient force to control the situation at Battle Hill, and he cited numerous complaints of a lack of control over the patients and employees, which had come to him. He stated the situation at Battle Hill in this respect had become worse the past few years. He also referred to the injunction suits filed by citizens asking that the institution be abated as a nuisance.

As the result of the statement of the mayor that he did not know that the election of a superintendent was to come up at the meeting, the election was postponed until next Tuesday, although the executive committee stated that the committee had evidently made up its mind, and there was no use in delaying matters.

During the course of the meeting Dr. Kennedy stated he had been informed by the city attorney's office that after an investigation of a shortage in his accounts, had made good shortage of \$850, by paying \$100 in cash, and relieving his title to \$100 in salary due him from the city on the date of his removal from office.

A site money was paid directly to the city treasurer, a special request being introduced in council to allow the reimbursement of the employees.

"Soldiers write that from Arras to Cambrai about eight miles the field is covered with corpses, and that the odor is unbearable.

"Reports from neutral sources declare the battle raged near Arras may decide the fate of France. Both sides fight with unabated courage and heroism. The French are very strong. The Germans continuously receive reinforcements. The losses on both sides are fearful."

General DeWet Is Sentenced

To Six Years for Treason

BLOEMFONTEIN, Union of South Africa, June 22.—(Via London).—A sentence of six years' imprisonment and a fine of two thousand pounds (\$10,000) was imposed today on General Christian De Wet, one of the leaders of the South African rebellion against the British government, found guilty of treason yesterday on eight counts.

Italians Capture Two More Forts From Austrians

GENOVA, June 21.—(Via Paris, June 22).—The Tribune prints the following dispatch from Ljubach:

"The Italians on the night of the 19th captured ground twelve miles north of Gorizia, while southeast of Flava they captured two forts and several trenches, in which were found two machine guns.

Along the Isonzo the artillery duels seem to have turned to the advantage of the Italians, and the Austrians are beginning to bring up heavy guns from the eastern front.

A council of war was held at Ljubach on the evening of the 19th. Archduke Eugen, commander-in-chief of the Italian forces operating against Italy, is expected to arrive on the Gorizia front on the 23d."
