PRISON OFFICERS TELL GRAPHIC STORIES OF SEIZURE OF FRANK

(Special Dispatch to The Journal.) MILLEDGEVILLE, Ga., Aug. 17.—"I was called to the door just as I was preparing to retire," said Captain J. M. Burk, superintendent of the state prison from a 6 o'clock Tuesday morning, "and following my usual custom I walked out. When I passed the threshold two strong men grabbed my wrists. Four others stood guard over me, two with shotguns and two with heavy pistols. "I remonstrated and they declared it was no use for me to squirm as they were immediately covered and ordered to throw up their hands. "Frank was not at my house and they said they knew that, but they were going to take me where they knew Frank was quartered. "I was marched up to the penitentiary building by a guard, which was redoubled as we proceeded. When we reached the building a demand was made for the gate to be opened and one of the men began cutting the wires and informed me the prisoner would be killed as soon as an entrance was effected.

FRANK SEIZED. "The gate was unlocked and Night Guard S. Hester came forward, but he was immediately covered and ordered to throw up his hands. Half way the steps I was halted while half a dozen men rushed by and made a dash for Frank's room. One of the prisoners who witnessed this scene declared that four men seized Frank by his arms and legs, while a fifth grabbed him by the hair and he was dragged out of the hospital rooms and bumped down the stone steps. With me looking on, Frank never uttered a word, but apparently he was suffering intensely and groaned as from pain inflicted in handling him in his wounded condition. "The crowd informed me that they did not intend to harm anybody except Leo Frank and told me not to have any fear. The affair was completed within five minutes. It seemed to me, and almost before we realized the enormity of the occurrence it was a written chapter. WOULD'NT REMOVE HANDCUFFS. "During the time I was handcuffed and under guard. When the crowd brought Frank down and started off I asked the fellow who had snapped the handcuffs to unlock them, but he laughed sardonically and stated that if I would accompany them that they would take off the irons. I reported by saying, 'Damned if I'd go anywhere with them.' "The whole procedure was timed as a well ordered and methodical proposition and there was no time for anybody to be suddenly arrested for a leader to do the talking. Only two of the men were masked, but I did not recognize any of them. Then in less time than it takes to tell it, they were off and I could see the lights flashing as they went over the hill towards Milledgeville, the road that leads Atlantaward."

THE WARDEN'S STORY. Warden James E. Smith of the state penitentiary system, described the attack as a very carefully planned affair. He said: "I was spending the night at my home adjacent to the main building, as I usually do under normal conditions. I had just gone in when I was called from the front. I inquired who it was, and then some name was given, a conciliatory tone was used, but I did not understand, but as my name was called familiarly I went to the door with a lantern in one hand and my other hand on my pistol. "When I opened the door half a dozen men confronted me with pistols and guns thrust into my face. They commanded me to throw up my hands, and there was nothing else to do, at that juncture my wife rushed up and fell swooning in my arms and the men ordered me to come on and go to the camp. "My wife interposed and they told her they were my friends and her friends and for her not to be afraid, but she kept clinging to me. Then one of the men said the man to go on, but he considered and said one or two more of them had better remain with me. They kept me covered for probably five or six minutes, then they took me and jumped into an auto passing by and were gone. The affair was consummated so quickly it is to be regretted it was carried out and I am completely at my wits' end in the matter."

Commissioners at Prison When Mob Seized Frank (Special Dispatch to The Journal.) MILLEDGEVILLE, Ga., Aug. 17.—The entire board of the state prison commission happened to be at the penitentiary late Monday night when Leo M. Frank was taken from the building. The board, consisting of R. E. Davidson, chairman; T. E. Patterson and T. E. Patterson, had arrived late Monday afternoon to begin preliminary work on the improvements planned for the penitentiary. This morning all three of them speak in most respectable terms over the occurrence they witnessed in person. They were spending the night at the residence of Superintendent J. M. Burk and had just gone into their rooms when the alarm was sounded that a mob had come for Frank. Chairman Davidson was first informed and he hurriedly imparted his information to Commissioners Patterson and Patterson and they made hasty effort to get on the scene, not fearing any personal violence, but before they could get to the prison grounds the mob was beginning to move off. Chairman Davidson said early today that he was unable to give out an official statement of the matter, but that later in the day the commission would issue a statement. He declared that the affair was so quickly carried out until to one hardly realized that any trouble was at hand. Commissioner Hatney voted the same as the other two. Judge T. E. Patterson said that it was one of the most disastrous occurrences that has been wrought in Georgia's history for many many years. Instead of pursuing their plans as originally planned and spending a few days in Milledgeville, Commissioners Hatney and Patterson left on an early train for Atlanta. Chairman Davidson will remain on the grounds and supervise the local situation. Frank's Parents Learn Of His Death by Mob (By Associated Press.) NEW YORK, Aug. 17.—When Leo M. Frank, learned definitely today that his son had been hanged near Marietta, Ga., they drew the shades at all windows of their home in Brooklyn and refused to answer the door bell of telephones. Neighbors said the Frank family had begun an eight-day period of mourning which was customary under the Jewish religion. Early callers at the Frank home were met by Otto Stern, Frank's brother-in-law. He said Mr. Frank and his wife were asleep and had not been told of the hanging of their son. Stern said he learned of the matter through the newspaper and within two hours the family had received word that Frank's body had been found.

Frank, preparing to go to her uncle's home in Athens when informed of the lynching of her husband, was undoubtedly prepared for the worst news. She announced that she had nothing to say in the way of a public statement. History of Frank Case Told in Brief Form Leo M. Frank was found guilty of the murder of Mary Phagan on August 25, 1913. He was the superintendent of the National Pencil company in Atlanta, in the basement of which the girl's body was found by a night watchman on the morning of April 27, previous. Repeated attempts were made in the state courts to obtain a new trial for Frank, but without avail. Attempts to obtain a coroner's inquest and the federal district court at Atlanta, and finally in the supreme court of the United States were fruitless. On the night of June 21, this year, two days before the date set for the prisoner's execution, he was removed from the county jail in Atlanta and rushed to the state prison farm upon orders from Governor Slaton, now retired. HOW MOB CARRIED OUT ITS ATTACK ON PRISON BUILDINGS

MILLEDGEVILLE, Ga., Aug. 17.—With vigilance probably somewhat relaxed because of the illness of Leo M. Frank, occasioned by the wound inflicted by William Green just exactly one month ago, the officials of the state penitentiary, together with the entire state prison commission, were compelled to watch a mob variously estimated at from twenty-five to seventy-five men take the state's most noted prisoner from the state penitentiary and lead him off to become the victim of lynch law.

Monday night, shortly after 10 o'clock, a well-organized mob invaded the premises of the state prison and despite official reports of preparedness, pandemonium reigned as a scene when Captain J. M. Burke, superintendent of the state farm and Warden James E. Smith, of the state penitentiary, were carried by the mob, handcuffed and Captain Burke was marched at their forefront while they proceeded to the prison, demanding admission. Hesitancy on the part of Night Guard Hester resulted in a preliminary attack on the barred-wire fence, accompanied by an order to Captain Burke to have the gates opened.

When Warden Smith was called from his room he faced five guns, and he was immediately handcuffed. His wife rushed on the scene and fell fainting into his arms. His wife rushed to leave her husband unharmed, and they assured her they were his friends and he would not be hurt. She entreated them not to take him away, and three men were left guarding him while the others joined the throng at the penitentiary building, two hundred yards away. When Captain Burke, who was the first to experience the violence of the mob, was handcuffed, an old trusty neighbor who works about the house rushed up to advise Chairman R. E. Davidson and Commissioners T. E. Eaton and E. L. Rainey that a crowd had come and handcuffed Superintendent Burke and that they said they were going to get Leo Frank. Hurrying to the scene, the commissioners were just in time to see them disappear in the direction of Eatonton, apparently headed for Atlanta.

Almost all wire leading into Milledgeville from the farm were cut and it was some time before a messenger was dispatched to Milledgeville to notify Captain Burke, Superintendent Burke's company, and Sheriff S. L. Terry. With all possible speed the officials got in touch with the situation and in a short time guards from the state prison and other officers were on track of the mob. REFUSED TO GO WITH MOB.

When Superintendent Burke was brought back out of the main prison building, a section of which was occupied by Leo Frank, he asked that the handcuffs be removed from his wrists. One of the mob stated that if he would accompany them they would remove them. The only approach to profanity used was when Captain Burke responded: "Dammed if I go anywhere with you."

The crowd was wholly under the command of a leader, who did what little talking was done. Consternation among the prisoners in the trust ward followed the entrance of the crowd, but the leader admonished them to remain quiet; that all they wanted was Leo Frank, and that they were going to have him. Entering the room he has occupied for the last month, five men seized him by arms and legs, while another caught him by the hair. A prisoner watching the proceedings stated that in this manner they dragged him from the building and down the stone steps, thrusting him into the front auto. This accomplished, a couple of men brought up a rope and flourished it in the convict's face. Throwing it down beside Frank, he was shoved down into the bottom of the auto and the procession then started on its journey to the unknown end.

FRANK DID NOT SPEAK. Throughout the ordeal, according to prisoners who gazed on the scene, Frank did not utter a word and only a groan escaped his lips.

Frank's wife, who has been with him constantly since the attack on his life, was in Milledgeville and shortly after the occurrence she was informed of what had happened. She had evidently steeled herself to prepare for the worst, but despite her strongest efforts she was overwhelmed.

The prison commission arrived here late Monday afternoon to begin work on the permanent improvements provided for by the state legislature recently, and it was in this way they happened to be witnesses to the first attack ever made on the state penitentiary here.

The news was not generally known in Milledgeville until morning and consequently there was but little excitement here. With the approach of morning, scores of people began scouring the country, but at 6:30 o'clock no further details of the occurrence had been secured officially or otherwise.

WORKED WITH PRECISION. The mob was orderly, but with quick precision. Eight automobiles took the mob to within a short distance of the prison. First, all wires from the prison and all except one from Milledgeville were cut. Five men went to the house of J. E. Smith, warden, covered him with pistols and stood guard over him. Another man went to the house of J. M. Burke, superintendent of the prison, and held him under cover of his guns. Practically every other member of the mob then rushed to the stockade and seized the dormitory where Frank was confined. One yesterday, the mob physician, Dr. J. H. Satterfield, bookkeeper at the prison, was awakened by some of the negro convicts and led off with Frank. As soon as he learned what had happened he hastened to Milledgeville and notified Representative Dennis.

The mob apparently planned their work well, for they carried it through without a hitch. Between Milledgeville and the state farm and between Milledgeville and Macon, they cut the telephone wires and it was fully an hour or more after they had secured their man and hastened on their way before the news came out.

As far as could be learned at an early hour this morning, none of the members of the mob was recognized. All of them are said to have worn masks and all were heavily armed.

Not a shot was fired and no one was injured as far as could be learned. One persistent report that a crowd was coming from Macon to guard the prison in the local community has not been substantiated.

GOING TO MARIETTA? A prisoner who was sleeping in the dormitory is responsible for the statement that the leader said the mob would be found on the grave of Mary Phagan, for whose murder the noted prisoner was serving a life sentence. As on the night Frank was taken, Chief Night Guard Hester and the other man on duty proceeded to the dormitory and within a few minutes seized Frank and rushed him back to the automobiles.

Those who had been looking for Smith and Burke left as soon as Frank was brought out to follow their fellows. The automobiles—reported to number eight—then were started in the direction of Eatonton. It is more than likely that the mob had been informed of the direction in which they were to go, for they were not far from the prison when they were first to see Frank out of the prison were almost of daily occurrence and not only were roads protected, but a large force of guards were kept on duty at the prison.

Mr. Herman said Dr. Smith examined the samples of milk and said that there was nothing wrong with it.

Mr. Herman said that none of the private families who sell milk in the city had reported any illness, and said that the sickness of the peddlers and others possibly was caused by eating watermelon or drunk with the milk at lunch.

WILSON PLANS MOVE TO BETTER COTTON SITUATION

May Give Support to Plan to Send Committee to England

WASHINGTON, Aug. 17.—President Wilson will take definite steps soon to better the cotton situation in the south, Representative Lever, of South Carolina, chairman of the agricultural committee in the last house, was assured today by the president.

The first step in the president's plan is to take up the cotton question in the note to Great Britain to be sent soon to protest against interference with trade between the United States and neutral nations abroad.

Official announcement of the decision of the allies to put cotton on the contraband list is expected here at any time. The exact position of the United States was understood until it is officially advised of the new action. It is generally understood that the move will be protested.

The state department has been advised unofficially but authoritatively of the coming action and such information as officials have received, coupled with the latest information from London, indicates that development of a plan for uniform cotton spinning in the United States and other powers is all that is delaying a formal announcement.

American officials have been assured that Great Britain and her allies will take every action to minimize the embarrassment to the American market, although it is contended that the allies claim American products, the allies have and contend it will substantially make effective the orders in council and accomplish by strictly legal means what has been attempted under the orders.

EVER since the application of the British orders in council to cotton, among other American products, the enemies have felt that some more effective method must be found for dealing with cotton and preventing its entry into Germany and Austria. The allies contend that American cotton shippers, in many cases alleged to be backed by German capital, have been shipping cotton to Germany through neutral ports.

Under the orders of council such a cargo, if captured, merely was taken into a British port and paid for by the British government. The allies contend that under these conditions a great deal of cotton got through Sweden, Denmark and Holland into Germany and advised him that cotton was used in the manufacture of explosives powder and the British government to buy cotton and at the same time offered an incentive to blockade runners.

According to the advice reaching Washington the pressure in England and France has compelled a change. The British government originally regarded cotton as non-contraband and expressed a desire to avoid inflicting hardship upon southern planters and to avoid development of an anti-British feeling in this country.

The change to contraband will be defended as authorized by international law. Great Britain protested against the American blockade of outgoing cotton from the south during the civil war, but will now contend that radical

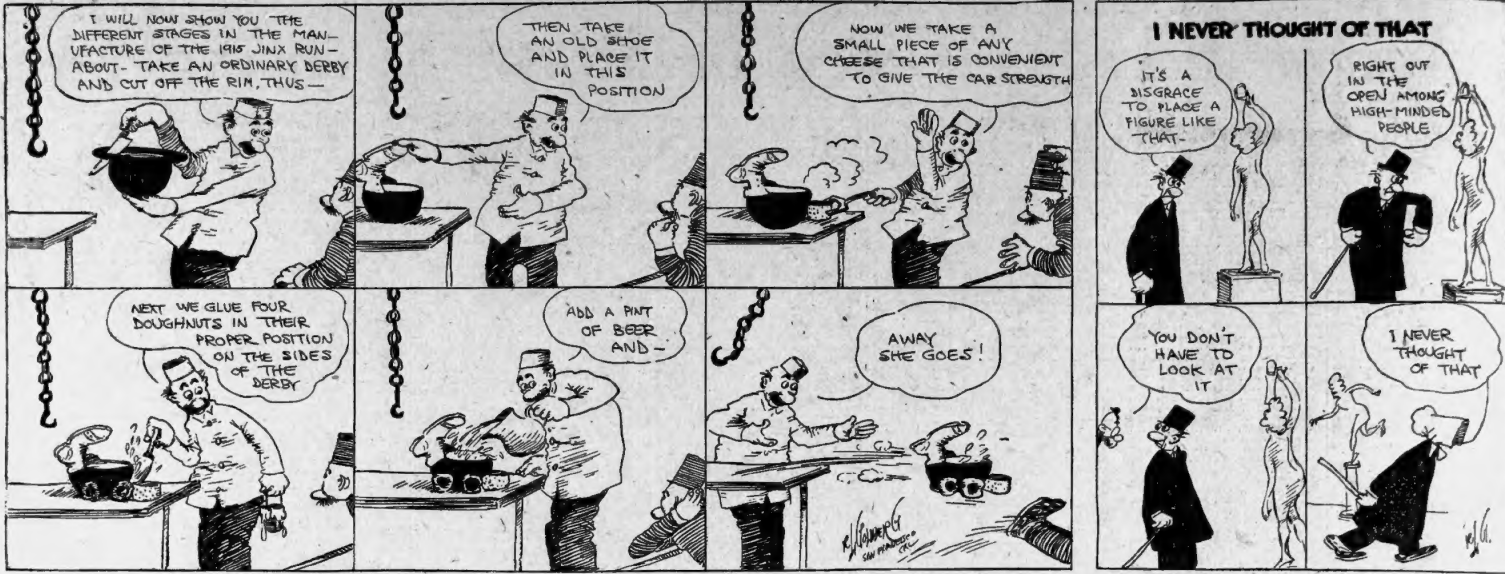

IMPERSONATES DORSEY TO SECURE RELEASE OF GIRL

Man Who Works Ruse to Get Girl Out of Training School Is in Jail

By getting a friend, supposedly a lawyer, to impersonate Solicitor Hugh Dorsey, a ruse was worked by J. W. Johnson, thirty-five years old, of West Harris street, by which he succeeded in abducting Miss Minnie Griner, sixteen years old, away from the Georgia Training school for girls Sunday afternoon. Late Monday afternoon both Johnson and the girl were arrested by County Patrolman Carter.

Miss Embree, superintendent of the school, which is a reformatory for girls sent up from the courts of the state, said that Johnson called up Sunday and told her that Solicitor Dorsey had consented for Minnie Griner, sent out from Fulton county, to leave the school on probation. Johnson further said that he was the girl's legal guardian and that he would come out and get her.

Then, said Miss Embree, a man telephoned out to the school and told her that he was Hugh Dorsey. Representing himself to be the solicitor, he told her to let the girl out and that Johnson, the girl's guardian, would call for her. Johnson, a mechanic working for the Dorge Motor Car company, then rode out the Baker Ferry road in an automobile to the school, got Minnie Griner and drove away with her.

Miss Embree's suspicions were by this time aroused. She ascertained from the solicitor's office that Hugh Griner had not instructed her regarding Minnie Griner's release. Monday night, Johnson, the pseudo guardian, rode out to the school again, accompanied by two young women in an automobile, to return to the state the girl who was away by Minnie Griner.

Johnson telephoned the county police, and County Officer Carter made a record down from his home in Battle Bluff to the county jail, where he arrested Johnson, charging him with driving an automobile in violation of the law. Johnson, the officer found the girl and took her back to the home.

Johnson was carried to the Fulton county tower and held there under a warrant sworn out by Miss Embree charging him with carrying a girl to escape from the home. His bond was fixed at \$1,000, which he did not make. Tuesday morning Patrolman Carter swore out an accusation against him in the city court, charging driving an automobile while intoxicated.

mentors for the Twenty-ninth division and details of the Royal army medical corps. Full information has not yet been received, but it is known that about 600 have been saved.

So far as reported officially this is the first instance in which a British transport has been attacked successfully by a submarine.

It had been a matter of pride with the British government that it had transported hundreds of thousands of troops without the loss of life.

The British announcement shows that the Royal Edward was engaged in conveying troops to the Dardanelles front. German submarines sent to these waters to harass the Turks have been very active.

One of them, the U-61, under command of Captain Otto Haring, made the voyage from Wilhelmshaven to the Dardanelles and sank the British battleship Tiger and the transport ship Royal Edward. The Royal Edward had been engaged in the war on August 11, 1915, when it was sunk by a German submarine.

The Royal Edward was 11,117 tons gross and 10,000 tons net. It was owned by the Canadian Northern Steamship Company of Toronto. She was built in Glasgow in 1909.

Premier Goussaris read the royal decree opening the session. The deputies then were in order for the election of a new speaker. Goussaris announced the resignation of the government and asked that sittings be suspended until the political crisis had been solved.
