A Victory for Georgia Merchants.

Georgia merchants are relieved of a grave handicap and injustice by the order of the Interstate Commerce Commission requiring the railroads either to withdraw the special privileges with which they have favored the grain dealers at Nashville or to extend those privileges equitably to Atlanta and other points in this territory. Nashville dealers have been allowed to ship carloads of grain from the West and then, after storing and sacking it, to re-ship it to Southeastern markets at the through rate from the point of origin to the point of destination. Georgia dealers, on the other hand, in re-shipping, have been compelled to pay the through rate from the point of origin plus local rate to the point of ultimate destination. Because of this discrimination, Nashville dealers have been enabled to undersell Georgia dealers in the latter's own territory; and especially pronounced has been the wrong to Atlanta interests.

This case has been in litigation for seven years. Once before the Interstate Commerce Commission directed that the unfair practice cease, but the Commerce Court, which subsequently was abolished, annulled the order. The Supreme Court reversed the decision of the Commerce Court, and now the Commission reaffirms its former order. The resultant benefits to Atlanta and other cities that have suffered from the flagrant discrimination will be far-reaching. Our merchants now can compete with those of Nashville on a fair basis and in an open field. They have sought only their simple rights, and those rights the Commission has recognized and vouchsafed.

This fruitful victory is attributable to the great value and service of the Atlanta Freight Bureau. Through seven long years the Bureau, and its able counsel, with the support of the Atlanta Grain Dealers Association, have contended persistently for the city's shipping rights, and in its crowning success it merits the gratitude and congratulation of the entire business community.

As the Russians View It.

Commenting on what it terms "the nonchalance" with which Russians regard the fierce Teutonic drive, the Literary Digest reproduces a number of singularly interesting opinions from the press of Petrograd and other cities of the invaded empire. Regardless of political creed, these journals which deplored the death of munitions strike a buoyant note as to their country's outcome in the war and insist that ultimately the very impetus of the enemy's advance will prove his undoing. This, for example, from the Novoye Vremya, of Petrograd.

"The Germans throw at us unheard-of masses of men and metal. They are exerting now all their strength in order to crush the Russian army and make it harmless for as long a time as would be sufficient for them to turn west against our allies. They do not take account of the enormous losses in men or the lavish expenditure of ammunition. One thing only is dear to them—time. Our enemies are maintaining hate. Our gallant army and its brave chief understand that, and are dealing fearful blows at the enemy during the temporary retreat. Our main concern is with the army, its strength and spirit. Its strength grows and its spirit does not weaken. Trusting in it we are not discouraged by the reverses of the time, but with undisturbed calm await the triumph of our cause."

Of the country's human resources, another Russian writer observes:

"No matter how many soldiers have gone to war, the supply of men capable of bearing arms is still enormously large. We have ample material to make up for the losses in our army. The Germans by their reckless expenditure of ammunition clearly prove that they need a speedy termination of the war at any cost. And we need its continuation. Each additional month, though not marked with success, increases the chances of our final victory."

However these views may be regarded they are interesting at least as expressions of Russia's virile faith in its destiny. Nor can it be doubted that the nation is capable of endurance and resilience almost unlimited. It may not be true that Russia "deliberately enticed Germany to follow her back into those vastnesses from which no previous invader has ever returned victorious," but it is evident that in a prolonged war Russia's enormous supplies of human material will count tremendously.

Grade Crossing Perils. The problem of grade crossings is serious enough even when trainmen and motorists alike exercise the utmost precaution. There will be accidents no doubt as long as unguarded crossings remain. These crossings ought to be abolished as rapidly as practical conditions permit. Meanwhile, however, the majority of such casualties could be averted by due vigilance and foresight on the part of automobile drivers.

It is well-nigh inconceivable that anyone not bent upon self-destruction would dash voluntarily across the course of an approaching railroad engine. Yet, the New York Commercial reports specific instances of drivers smashing their automobiles through closed crossing-gates and plunging over the tracks in front of moving trains. "The Long Island Railway," the Commercial says, "is now constructing gates of telephone poles to see whether this will stop fools from imperiling their lives in this way."

Tact in Business.

SMOKE a certain brand of pipe tobacco. It is a "popular" brand, and by no means expensive. One day, wishing to replenish my supply, I asked for a pack at the tobacco counter of one of Boston's largest grocery stores. I received the reply: "Sorry, but we don't keep that. I can give you some tobacco, though—that is much better. We keep only the best kind."

It was said civilly enough. There was no thought of insult. But inwardly the thought flashed into my mind: "If a dealer if all the clerks in this place are as tactless as this fellow!"

If they were, I could readily understand why, large though the store was, there were very few customers there.

Tact, it is to truth a business asset of the first importance. It is so important that all business establishments should make it a point to train their employees to handle customers and prospective customers tactfully.

Some firms already do this very thing. I have especially in mind a colored New York trading corporation, with stores located in many cities. "Be tactful" is virtually the slogan of this corporation, and the financial success it is enjoying testifies convincingly that tact pays.

To be tactful does not mean that one should be cringing or fawning. It means simply that one should always be taken to avoid wounding the susceptibilities of those with whom one is dealing.

Even seemingly so small a matter as unreasonably calling in question a customer's judgment on a hat, a shirt, or a necktie, may mean the ending of all business that day.

Yet there should be no object, deferential slyness—no obsequious eagerness to sell a man the thing he wants just because he wants it.

It is this, and only this, that a lasting good-will is established between salesman and customer, whether the salesman be working behind the counter or on the road.

Tact, accordingly, is one of the prime essentials of the successful salesman, and a man who has it said of him that he is a "born salesman," it is equivalent to hearing him described as a man pre-eminently blessed with tact.

Nor is it only as regards salesmanship that tact is a business asset. The doctor, the lawyer, the broker—the very man, in short, who is dependent on the good-will of others ought to make it a point to develop tact behind the scenes.

This implies, of course, the cultivation of self-control. No man who is not habitually self-controlled can be tactful.

Consequently the development of tact involves a mental and moral discipline that has a tremendously beneficial effect, not only on a man's business affairs, but on his life as a whole.

NO. 267—FARAMARIBO. The principal city and seaport of Dutch Guiana in South America, Faramaribo is probably one of the least known cities in the world, except to the Dutchman who control it.

It is the best glimpse of Faramaribo can be obtained by riding on the Electric Streetcar. The street runs from the Waterkant to the railroad station. Here swarms the motley population of this equatorial city in all its strange variety of kind and color.

The predominant type is the so-called "Dutch Black" who varies from the hue of pitch to a deep chocolate brown. Next to the descendants of African slaves imported by the Dutchmen. These are dressed both men and women in wide skirts. Next in number are the coolies, who may be East Indians, Mohammedans, or Hindus. They are clad in rags and in the narrow skirts of a so-called "bush niggers," also of African descent, who lead a wild and independent existence in the marshes and swamps of the interior. They are a fine, strong, sturdy, and warlike lot.

Of white men—Dutch, English and American—there is but a scattering. In the years before 1863, slavery in a tremendous scale existed in Dutch Guiana. The result that the Africans overran the country. They far outnumbered all other elements in the population and the white men were driven to the coast.

In 1863, however, slavery was abolished, and the freed slaves were now free to work for their own masters and chiefs; they practice polygamy, the number of wives a man can have being limited only by his ability to support them. They are under no more restrictions than are the whites.

Dutch Guiana, despite her queer population, is commercially prosperous. Sugar, cocoa, coffee, bananas and other tropical fruits have long been produced there. Recently, wild rubber has been sent out in quantities, while her tropical forests, where mahogany, cedar, greenheart and many other valuable woods are found, constitute an untouched resource.

ITALIAN POLICE BEFUZZLED IN WAR

ROME, July 20.—Traveling in Italy just now is like the wanderings of a blind man through a mystic labyrinth. At every step one is liable to bump against an unforeseen obstruction. It is not that the regulations are formidable, but that one cannot discover what they are. In one town a rule is strictly enforced that is a dead letter six miles due east. Sometimes a regulation is published in the newspaper and nowhere else. As a result of what began as a perfectly innocent journey I spent some hours of my time in arrest. Respite of literature have been added to the archives of the Italian police. In half the police stations that sunny atmosphere of the kingdom's police-headed copper are probably now trying to memorize my mother's maiden name, and to harmonize my allegation that I was born in Toledo, O., with the known fact that Toledo is in Spain.

"Can I go to Venice?" I asked Cook's man in Rome. "Certainly," he said. "No trouble at all. No special pass needed. Just get on the train and go." I wanted to visit the little republic of San Marino. That was quite easy. One had only to obtain a passport.

"Your passports, signor," said the detective at Piombino. "We were one of those small detectives that switch Italian cases. There was nothing wrong with the passport, but he stood about ostentatiously and watched until we got on the train for Rimini. Many small howlers had been noted by the detective. We were in the war-zone, it appeared. Therefore we were potential spies. Rimini had been bombarded twice lately by an Austrian squadron from the Adriatic, and Rimini is nervous. We were held under close arrest in the inn of the Leon d'Oro.

"You must leave on the 3 o'clock train," we were told. "But we wanted to go to San Marino. San Marino is a republic. It has been a republic for one thousand years. Kepler Wants Strike and Others Urge Campaign for 8-Hour Day

(By Associated Press.) WASHINGTON, Aug. 19.—When the executive board of the International Association of Machinists met in continuation of its session here today, J. J. Kepler, vice president of the organization, was on hand ready to urge his proposal for a national strike in munition plants of the country to enforce the eight-hour day, despite the board's action yesterday in repudiating the proposal. The board, however, decided to conduct a general campaign for a shorter workday in all shops.

W. H. Johnson, international president, who was authorized to disavow the strike project, said that an intention attributed to Kepler declaring that he would urge a strike was unauthorized by the association and was at variance with its policy. "We have not declared for a general strike," Mr. Johnson added. "In fact, we will use every means to prevent such a development."

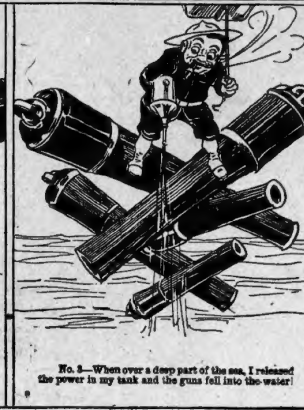

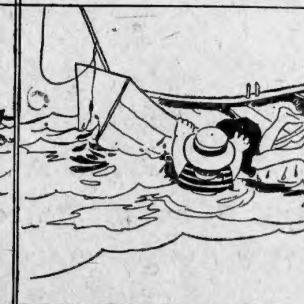
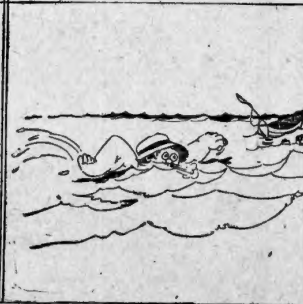
